

On the above date at 10:00 A.M., the Luzerne County Board of Commissioners convened their regularly scheduled meeting with the following present: Gregory A. Skrepenak, Chairman; Rose S. Tucker and Stephen A. Urban, Commissioners; Samuel T. Guesto, County Manager for Legislation/Chief Clerk; James Blaum, County Solicitor; Salvadore Diaz, Chief of Budget and Finance.; Michael Morreale; Treasurer; Maryanne Petrilla, Controller; Doug Richards, Director Human Resources; Joseph DeVizia, Director of Human Services; Andrew Reilly, Director of Community Development; and Gregory Hunsinger, Director of Purchasing, Joe Gibbons, Engineer, Adrian Merolli, Director Planning; Doug Pape, Interim Director Luzerne/Wyoming Transportation; Paul McGarry, Directory Probation Services.

Commissioner Gregory Skrepenak called the meeting to order and asked everyone to join in saying the Pledge of Allegiance followed by a moment of Silent Prayer. It is noted that all meetings are electronically recorded.

Commissioner Skrepenak reviewed the protocol for Public Comment and directed Mr. Samuel Guesto, Chief Clerk, to ensure the five-minute time limit is adhered to.

PUBLIC COMMENT

Al Akulonis, Jr., Duryea, stated for the record that no one has paid him to be here. He thanked the Commissioners for working so hard in this community and for doing a great job. He pointed out the good things the commissioners have done and there support for Junior Achievement, preserving farm lands, adoptions, Domestic Violence Awareness, Juvenile Justice Week, Assisted Living Week, LCCC, Juvenile Probation Youth Symposium, Safe Schools initiative, recreational parks. He stated that we learn from our mistakes and that it's time to forgive and forget and move on. Leave these courageous servants in Luzerne County do their job.

Todd Klein, echoed Mr. Akulonis's comments that the commissioners are doing a good job and that the debit card policy is flawed, but can be fixed. He commented on the frivolous law suit that Commissioner Urban voted repeatedly to support. He asked for Commissioner Urban to take responsibility and resign as minority commissioner. There was a lengthy discussion on the lawsuit and the debit card policy.

Joe Naperkowski, asked for the resignation of Commissioner Skrepenak, Mr. Guesto, Mr. Blaum, Mr. Brace and Mr. Hyder due to the debit card circumstance.

Keith Sorber, asked Commissioner Skrepenak, and all other debit card holders to resign and get out of the Courthouse forever.

Tim Grier, Wilkes-Barre, commented on the debit cards and the Juvenile Detention Center and the TAN. He asked Commissioner Urban to put in writing a request for investigation into the debit card holders to the new District Attorney.

Robert Posotski, Wilkes-Barre, representing the Building and Trades Commission, Local 130, commented on the direction the county is going in. He stated he believes we are going in the right direction pointing out the movie theater, the Sterling Hotel, jobs that have been created. He called for the commissioners to continue in that direction.

Mr. Gustitus, stated his concern for financial responsibility in government and talked about debit cards, the Juvenile Detention Center, and the budget. He asked for fiscal responsibility and for the commissioners to respond to the people and resolve the issues.

Walter Griffiths, Jr., Wilkes-Barre, stated his appreciation of Mr. Skrepenak being on time and his concerns on the budget. He asked that current employees research the policies instead of hiring an outside consultant. He stated his disagreement in giving the Wilkes-Barre Chamber tax forgiveness on properties and commented on the debit card circumstance and asked for a motion to go off the agenda to fire those debit card holders. He stated he believes there is integrity and trust issues and that we need to restore that trust by following policy.

Todd Vonderheid, Wilkes-Barre Chamber, made a presentation for forgiveness on 2 prior loans provided by the Chamber and affiliates. There was a lengthy discussion and Commissioner Urban recommended tabling this motion until further information could be obtained.

Joe Hillard, Freedom Works, commented that what is going on in Luzerne County is symptomatic at every level of government. He questioned the budget and asked that the commissioners treat every taxpayer dollar like a precious commodity and live within a realistic budget.

Bob Reilly, Wilkes-Barre, stated that there is nothing wrong with people coming to meetings and voicing their opinions, as long as there is not an agenda. He asked that people come up with some positive things that can be done, not only for the benefit of the individuals that are doing it but, for everybody, for every taxpayer in Luzerne County. He stated that all the debit card holders are dedicated to their jobs and asked that Mr. Guesto does not resign and that he appreciates the great job he is doing and the communications between their offices that helps him to do a better job.

Mayor Tom Leighton, Wilkes-Barre, stated he is here on behalf of the city of Wilkes-Barre and thanked Commissioner Skrepenak, Commissioner Vonderheid, Commissioner Tucker, Sam Guesto and Bill Brace for all their cooperation and support in restoring downtown Wilkes-Barre. Commissioner Urban stated he also supports Wilkes-Barre and mentioned projects that he voted for.

Commissioner Skrepenak stated that as of right now, there will be no layoffs. He stated this was achieved by Department Heads and Row Officers coming to the front with numerous ideas and advances to assist us in our greatest time of need. They have been doing everything they can to find money and to help us with paying the TAN. In addition, we requested all reimbursements earlier than normal particular from our tax collectors.

Sam Diaz, Chief, Budget and Finance, outlined the proposed 2008 Budget. A lengthy discussion followed.

Commissioner Skrepenak, on behalf of the Board, congratulated Mr. Diaz, Sam Guesto, Jr, Chief Clerk, senior staff, Row Officers and Department Heads for their efforts and contributions to this budget.

Commissioner Urban noted he will not support the 2008 Proposed Budget citing his major concern with this budget, as with past budgets, is that they are all based on debt.

Commissioner Tucker recognized all the people that were involved in preparing this budget stating that they did a yeoman’s job and a great deal of work to get it done.

BE IT FURTHER RESOLVED AND ENACTED, that for the expenses of Luzerne County appropriated from the revenue available from the year for the specific purposes set forth below, which amounts are more totally itemized in the County Budget Form on file in the Office of the Luzerne County Commissioners, Hazleton Courthouse Annex, and the Luzerne County Law Library.

Commissioner Urban stated his disappointment with Mr. Blaum and his handling of a \$300 dollar reimbursement to the County.

Mr. Blaum stated when he received the records on November 21st he acted immediately to reimburse the county. Mr. Blaum also stated that not once has Commissioner Urban approached him about any concerns he may have had about him or the way he does his job on behalf of the county.

Commissioner Tucker stated she has worked very closely with everyone of these people that Commissioner Urban is asking to discharge and a better group of men and women she has not had the opportunity to work with in government until this time.

Mr. Guesto stated that he also has not been approached by Commissioner Urban and that he approached him on several occasions and Commissioner Urban has declined to meet with him. Mr. Guesto stated that he has given PNC Bank permission to release the statements to him.

Mr. Richards declined to comment at this time, but did concur with Mr. Blaum that he has not been approached by Commissioner Urban with regards to this issue.

Mr. Brace stated he will address this issue in the future through litigation.

Commissioner Urban motioned to go off the agenda. There was no second, motion to go off the agenda died.
