**CALL TO ORDER:.....Maryanne C. Petrilla, Chairperson**

Commissioner Petrilla stated in preparation of the county's upcoming hearing it was determined by the Chief Solicitor, Vito DeLuca that Salary Board Meetings are to be held on the first Monday of every year to reappoint all positions within the County. Commissioner Petrilla went on to explain how each Department Head or Row Officer will vote for their department. Commissioner Petrilla stated that if a department or row office does not have a department head the voting member will be the County Manager/Chief Clerk, Doug Pape.

Commissioner Skrepenak asked for clarification on the voting members.

Commissioner Petrilla responded that the voting members were the County Controller, the three Commissioners, where applicable the Row Officer, where applicable the Department Head, and when there is no Department Head or Row Officer the Chief Clerk.

Commissioner Skrepenak asked the County Solicitor to verify this.

Vito DeLuca responded that the statute was very clear. He stated that the Department Head is a sitting member of the Salary Board when there is no Row Officer. He stated that when there is no Department Head the Chief Clerk would be the Chief Executive of that department. Commissioner Skrepenak questioned if there are always five members on the board. Mr. DeLuca responded that it is always five members.

**PUBLIC COMMENT:**

Walter Griffith asked for clarification from the Solicitor on the salaries of the court employees in regard to the injunction. Vito DeLuca stated that the Salary Board is a defendant in the case as well. He stated the injunction had indicated by agreement of the parties that the Courts would continue to be funded at the 2008 level. He stated that the process today was to put the County in complete compliance with the County Code.

Walter Griffith stated that the county is now under the 2009 budget. He stated that someone needs to direct the County Controller to pay the court employees under the 2008 budget.

Vito DeLuca stated that the Salary Board is also a defendant in the action and is also a party to the injunction. He stated the Salary Board is just as bound as the County to the injunction.

Mr. Griffith stated that his concern was how the Controller can issue paychecks when there is no documentation from the Commissioners stating that they are to be paid out of the 2008 budget.

Vito DeLuca responded that there is an agreement on the injunction signed by Judge Rehkamp in which the County is honoring.

Mr. Griffith questioned if that was signed after the mandamus. Mr. DeLuca responded yes, after the parties agreed the County was concerned that if there was a delay in the proceedings the entire County could have been in jeopardy of not being able to enact the 2009 budget with regard to any department or row office. He stated in trying to continue on with the rest of county government they came to an agreement with the courts that they would continue to be funded at the 2008 levels and the county would make no court layoffs or furloughs until a final hearing took place. Mr. DeLuca stated that the county is in a bizarre situation where we have what was to be a 2009 balanced budget and we are using 2009 budget figures for every other county department other than the courts.

Mr. Griffith stated that he was concerned that the courts were bullying the County and the Commissioners.

Mr. DeLuca responded that anyone who has viewed the situation and would state that the Commissioners are intimidated by the courts was not paying attention. He stated that the Commissioners were not intimidated and they would continue to go forward with the lawsuit.

Mr. Griffith replied that he didn't mean to allude that they were being intimidated, he just wanted to give them tools to try and hold the budget where it needs to be.

Thomas Concert stated for eighteen years he has been trying to deal with the family resources within the County. Mr. Concert stated that his questions and concerns have been put on the back burner. He stated that individuals do not follow their protocol or procedures within their duties. He stated in his situation something simple turned into a criminal investigation by an individual working for the County. Mr. Concert stated that he has two children he is trying to bring home. He stated that there are many parents and grandparents trying to reach the same goal. He stated that he is looking for a Court of compassion not intimidation to lead parents in the right direction.

Commissioner Petrilla questioned if going from an hourly salary to an annual salary would be reflective in the 27<sup>th</sup> pay. Deputy Budget Director, Joan Pusteri responded that the hourly rate will remain the same, but the total annual salary will increase overall by the one additional pay period (27<sup>th</sup> pay) in 2009. Commissioner Skrepenak questioned if an elected officials salary would fall under the 27<sup>th</sup> pay period. Budget Director, Tom Pribula responded that it would not because an elected official's salary is set and they cannot be paid more. Mr. Pribula stated that the county should look at converting their payroll to the 15<sup>th</sup> and end of each month so every year will be consistent.

Human Resources Director, Doug Richards responded that he was not familiar with the regulations in regard to an elected official's salary however he did review two court actions with the same situation in which both counties lost the case. Mr. Richards stated that not only does this come up every eight or nine years but the county is also in a situation where we have a lot of people hired as salary employees. He stated if you would look at your paycheck there is an hourly rate listed. Mr. Richards stated that he understood the Commissioner's concern about the employees salaries being approved on a 27 pay rate but the county is bound by law to pay the employees' that hourly rate. Mr. Richards stated that the county's payroll system requires that an hourly rate be inputted even though we are salary. He stated that all the salaries were put into the approved budget.
