Create: One (1) Naturalist Assistant position at \$5.85 per hour from May 1, 2006 thru October 1, 2006.

Create: One (1) Marina position at \$5.50 per hour from May 1, 2006 thru October 1, 2006.

Create: Two (2) Marina positions at \$5.35 per hour from May 1, 2006 thru October 1, 2006.

Create: Three (3) Conyngham Township Recreation Aides positions at \$5.35 per hour from May 1, 2006 thru October 1, 2006.
