Luzerne County Auction Rules

1. By Bidding, each bidder agrees to the auction terms and conditions.
2. All sales are final.
3. The auction item value is an estimated fair market value.
4. Payment for items purchased must be made in full the day of auction. The County will accept checks, business checks, cashier's check or money order made out to **Luzerne County**. **No Credit Card payments will be accepted.**
5. Following payment, you may pick up your purchase. **Note:** If you are purchasing a vehicle, you may pick up the vehicle after the Title has been transferred.
6. The County reserves the right to add or withdraw items, without notice, to or from the auction.
7. Each person bidding assumes all risks and hazards related to the auction and items obtained at the auction. Each bidder agrees to hold harmless from any liability arising indirectly from Luzerne County, their elected and appointed officials, members and employees.

Silent Auction Bidding Process

8. Opening bid amount should be printed on the bid sheet along with the incremental bid amount.
9. To place a bid on a silent auction item, bidders write in their bid amount on the bid sheet.
10. Incremental bids that don't meet your minimum incremental bid amount are invalid bids.
11. All decisions by **Luzerne County** are final.
