First I do not have a resumes' for Mr. Balliet.

With regards to the Tourism Board, I specifically informed Mr. Mackin that Rebecca Brominski, married to my nephew, would be in conflict of interests and her appointment would pose a possible ethics violation, because he stated to me her appointment would enhance the chances that tourist promotion activities could be directed to the LCCC. Rebecca is an employee of the LCCC and I told him her appointment would be a conflict. I immediately after the meeting called Mrs. Brominski to inform her of that fact. She said she "understood" but wanted to try anyway. I think the director of the tourist agency showed his complete lack of leadership by allowing her name to be placed in consideration for appointment by vote of their board. In the same vein, after a mental review and consultation with others on council, I believe that Mr. Gennetti is also in conflict of interests. Being on the Tourist Board could afford him the opportunity to vote to direct tourist activities to our area, and possibly to use his Hotel as a venue for such activities. People coming to our area could use his establishment as a place for lodging and respite. I feel that would be a conflict for him to participate as a voting member of the board helping to get tourists to realize the touring opportunities we have to offer.

With regards to the LCTA, Mr. Chepalonis sat on the LCTA Board throughout all the problems they experienced over the last few years, and steadfastly made no comments regarding the abuses or offered any help to rectify them or prevent any future occurrences. In addition, as Manager with The Martz Bus Co., government funds come throught the LCTA to Martz, and he is involved not only in approval of those disbursements but their receipt and distribution. Those funds are tied to senior ridership totals.



As you know, last week CCAP unveiled its 2015 county legislative priorities, with rewriting the 911 law as the top county priority for this year. Given the pending expiration of the wireless fee on June 30, timing is critical and grassroots support will be essential.

As part of our comprehensive 911 strategy, CCAP is asking every county to adopt a local resolution supporting reform to share with its legislative delegation and the administration. Specifically, we are asking counties to adopt the resolution this week or as soon as practical, as a concentrated effort to emphasize the immediate need to move forward with a comprehensive rewrite. This timing will dovetail with last week's

priorities announcement, as well as hearings by the House and Senate Veterans Affairs and Emergency Preparedness committees on the issues last week and this week.

CORRECTIONS

Housing an average of 700 inmates - 500 inmates in the Main Facility and 200 in the Minimum offenders Unit, the Luzerne County Correctional Facility is an integral part of our public safety network.

During 2014 the Correctional Facility's population has changed dramatically, experiencing the same problems as many of America's larger urban cities. The profile of the typical inmate has changed to a more hardened drug addicted offender and a younger, gang related violent offender.

New drugs replace the old — "K-2 Spice" and "bath salts" are seen more frequently in our community, resulting in violent reactions due to reformulation of their chemical makeup. Addiction and behavioral health issues among inmates probably make the Correctional Facility is the single largest provider of mental health services within the County with a caseload of over 180 inmates, of which nearly 90 are on some form of psychotropic medication.

Throughout 2014 there were 357 behavioral health-related incidents, with Correctional Officers assisting in preventing 17 suicide attempts and over 100 attempts of inmates harming themselves. Fortunately, No suicides were reported in the past year.

Another exploding population trend is the increased number of females entering the criminal justice system, having committed more serious, violent offenses than previously. The facility's female population has increased to the point where the overflow must be accommodated by the transfer of inmates to other institutions.

Throughout the year the Correctional Officers and staff at the Luzerne County Division of Correctional Services valiantly continue serving and protecting the community and the inmate population in providing safe and secure correctional facilities and programming.

HUMAN SERVICES

Luzerne County Human Services has done better than a number of counties in managing its resources and serving its most vulnerable populations. The County's participation in the Human Services Block Grant – which we joined as a pilot county in 2012 - has given Luzerne County the flexibility to apply some Human Services funding to programs where it is needed most.

Child Welfare and Drug and Alcohol programs have been the primary beneficiaries of that flexibility, enabling services to more consumers than would have been possible under the previous, strict funding guidelines. More administrative progress can be made with the Block Grant, and the agencies involved are working to most effectively target the distribution of funds.

As many of you know, our Children and Youth agency has had significant cash flow issues, brought about primarily through two main policy insufficiencies: timely submission of claims for State reimbursement and significant under budgeting. Other issues include process monitoring, both fiscal and programmatic and philosophical differences on where the agency is and should be headed.

Children and Youth faced a referral crisis as provider payments were nine months in arrears. The agency worked with the local provider association and the state Office of Children, Youth and Families to craft a repayment plan that keeps the referral options open. It is incumbent upon the Agency to fulfill the terms of that agreement.

Compounding these challenges, Children and Youth had significant turnover during in 2014. The agency's director left in 2013 and was not replaced until more than half way through 2014. The chief fiscal officer and the assistant director also retired. For the time being, the Human Services fiscal officer is managing the fiscal departments of both Human Services Administration and Children and Youth.

Looking forward, Children and Youth worked with the state to engage Public Financial Management to review the agency's fiscal policies and processes and help the agency develop a strategic plan for future fiscal soundness. Their recommendations will be available later this year.

Further, Children and Youth, like child welfare agencies in all Commonwealth counties, is tasked with implementing a new comprehensive data-base for reporting cases of neglect and abuse as well as the directives of 20 other pieces of legislation focused on keeping children safe as a result of the Jerry Sandusky incident at Penn State.

Mental Health and Developmental Services is for the most part funded through the Human Services Block Grant. During 2014, a new director was hired, although the director was a long time employee within that agency. 2014 saw some challenges but these challenges were met head on and consumers have benefited from these changes and will continue to benefit in the future.

Early in 2014, a major provider of developmental services ceased to operate. This provided an opportunity to rethink the service delivery system to individuals facing developmental challenges. Additional community supports were created and instead of relying on center-based services like workshops; community based services were developed that enable additional consumers to have real-world employment opportunities, additional community recreational opportunities and the supports they need for their personal level of development.

As a result of this shift and tighter management policies, the Mental Health / Developmental Services department is better able to contribute to the well-being of consumers and families and has been restructured a way that financially benefits the agency. The revenue generated by this service not only covers all costs associated with administration and direct service provision, but any additional revenue is used to provide a higher level of service to consumers and families.

Luzerne County has been fortunate to receive funding through the Community Hospital Integration Projects Program or CHIPP. Locally, the funding was used not to build additional group home capacity but to assist longtime residents of the area state hospital to reenter the community land live on their own, with the supports they require.

Originally funded to move 10 individuals from the state hospital into the community, at least 14 consumers have been transitioned to community services. In addition, some of these funds have been used by the public defender's office to hire an attorney to work with incarcerated consumers to facilitate their transition from the Luzerne County Correctional Facility and into appropriate treatment and other supports required to maintain themselves within society.

After an exhaustive search to fill the vacant position of Executive Director of the Luzerne / Wyoming Area Agency on Aging, that department head was, in turn, appointed by Governor Wolf to serve the Director of the Pennsylvania Department of Aging only a month after she was hired here. Consequently, a new search for a director has begun and the Area Agency on Aging Advisory Board will take an active role in the interview process.

The new active adult center in Kingston is now the most attended center of the 17 sites managed by the Area Agency on Aging. Plans are being finalized to install a dance floor that will expand the range of activities offered at this site. The Kingston Center prides itself in offering a wide range of activities in there center and does not rely heavily on outside activities, such as bus trips, for center participants.

Plans are moving forward to relocate the active adult center in Nanticoke. This center has been housed at the old Specialty Hospital but the site has been sold. The RFP for the new building is being rewritten and reissued.

The Office of Veterans Affairs has used the retirement of a long time staff to reorganize duties within the office and create / reclassify two staff positions. These new positions are certified Veteran's Services Officers and are able to provide a higher level of benefit services to the veteran population of Luzerne County.

JUDICIAL SERVICES AND RECORDS

The Division of Judicial Services and Records was the focus of Home Rule's greatest changes, consolidating in one agency the former offices of five elected row officers. The Division continues pursuing more efficient ways of serving Luzerne County's residents and the professionals that daily use its offices.

The Recorder of Deeds and Register of Wills offices merged into one location in February, 2013 and have been cross training since that time. The Division offers e-filing of Recorder of Deeds documents with the exception of Maps and Notary Registration since November, 2007. We also offer on line access to Recorder of Deed records back to 1963 through the software vendor.

The office is currently back scanning the remainder of deed records from 1962 to 1786. This project will be completed, and records available online, by the end of 2015. The Register of Wills office also offers an electronic marriage application, allowing couples to fill out all pertinent information prior to coming into the office.

Further, the office is currently discussing the requirements and protocol for e-filing of probate documents. Currently the office offers Skype services for the swearing in of personal representatives of estates, eliminating the need to travel to the Wilkes Barre office. Register of Wills records are available on line back to 2005 with future plans to back scan marriage license records and estates.

The Prothonotary office will change its case management system, enabling the office to operate more efficiently and provide the ability for future enhancements at no cost to the taxpayers. The Prothonotary office currently offers 22 different types of e-filing, with the goal of increasing that number to include all civil filings with the new system.

Prothonotary records are available on line back to 2004 with future plans to back scan beginning with Naturalization records. The employees have been cross training since the last quarter of 2013 and will continue to do so with Clerk of Courts staff.

The Clerk of Courts office uses a State-mandated case management system, CPCMS, on which more employees have been trained since the implementation of Home Rule. Prior to Home Rule only a few employees received the mandated training, severely crippling the office when an employee had time off. The Clerk of Courts office seeks more opportunities to improve its processes an increase the back-scanning of records to limit the number of files requiring physical retrieval from storage. Currently records are electronically available as far back as 1996.

The Division is currently planning a full merger of the Prothonotary and Clerk of Courts offices for an environment more conducive to efficient document management and retention.

The Sheriff's office has also been reorganized since the implementation of Home Rule. Task-oriented Divisions were created within the department, and three supervisory Lieutenant position were created – without increasing total salary or position count - to better supervise and improve efficiency and workflow.

This month, the Sheriff's Office opened a Hazleton satellite location for obtaining concealed weapon permits. The office, co-located with the chambers of Magistrate Dixon, is open Mondays, with services available all other workdays in the main Courthouse.

The Sheriff's Office has recently released a Request for Proposals for a case management system supporting its warrant, prisoner transport, real property, civil and protection from abuse program areas. Such a system is expected to reduce the office's reliance on contracted services, as well as support implementation of recommendations in the Auditor General's recent report.

ADMINSTRATIVE SERVICES

During 2014, the Administrative Services Division brought new leadership on board, with the hiring of department heads for the key areas of Information Technology, Human Resources and Purchasing.

Much of the Division's focus during 2014 was on laying the groundwork for significant progress in 2015. Requests for proposals were issued for moving the County to a Voice over IP telephone system and centralized managed print services, both of which will be implemented this year.

Fieldwork began in 2014 for an independent classification and compensation study of positions not represented by collective bargaining units. Two hundred non-represented staff in the executive branch have not received a general wage increase in seven years, while their weekly working hours were increased in 2014 by 15%.

At the same time, staff represented by collective bargaining units have negotiated numerous wage increases, creating compaction issues – minimizing or eliminating salary differentials between supervisors and line employees – in many departments. As a result, recruitment of management employees has proven most challenging.

Rather than address equity issues on a position-by-position basis in response to individual requests, the Division commissioned this objective study to provide the executive and legislative branches with independent information before making any compensation recommendations.

The Purchasing Department, in conjunction with the Office of Law and the County Manager's office, has implemented the contract management module in its financial management software to help insure timely contract execution, facilitate an earlier issuance of bids and requests for proposals, and aid departments in monitoring contract encumbrances and compliance.

Looking even farther down the road, the Human Resources Department has implemented an internship program with local colleges and universities which, this semester, has five interns placed in our offices, including two in the County Manager's office. We look forward to expanding this program significantly during the summer and fall semesters.

OPERATIONAL SERVICES

During 2014, the County recruited a permanent Division Head for Operational Services, replacing a succession of interim appointees in the position since the beginning of Home Rule.

Perhaps the most significant, and contentious, issue the Division addressed during 2014 was the transfer to the Commonwealth of lands associated with Moon Lake Park, the Seven Tubs, and the so-called Missing Link parcel. Following consultation with, and recommendation by, the Luzerne County Recreational Facilities Advisory Board, the Executive branch obtained Council authorization to negotiate such a transfer to the Commonwealth.

Council ultimately adopted a transfer agreement with the Department of Conservation and Natural Resources which resulted in the commitment of \$1 million in state funds to improve visitor access and experience at Moon Lake and the Tubs, while providing adequate safeguards to insure maximum beneficial use by County residents.

In 2015, Operational Services is poised to implement significant projects with a long-term impact on County operations. Responses are now being evaluated from a request for proposals for a maintenance management system — a computerized database for preventative maintenance at hundreds of thousands of square feet of County facilities, for management of the County's passenger and heavy equipment fleets and for management of millions of dollars in County capital projects.

The Division is now drafting a Request for Qualifications to engage an Energy Savings provider to conduct an investment-grade audit of energy use at County facilities and develop a plan for infrastructure improvements that will maximize energy efficiency at no capital cost to the County.

Prior to entering into such an agreement, however, staff will pursue an audit of all utility and telecom bills to insure accurate billing at correct rates. Finally, staff is negotiating a procurement contract which will lock in the best possible utility rates for County facilities.

I am an average working individual who knows the struggle of our Luzerne County citizens. They cannot hold the full burden with higher taxes on their backs.

Each tax hike resulted in overspending. The Lawton Administration gave us late audits and spent millions more than budgeted.

While I agree with Luzerne County Councilman Edd Brominski to live with the 2014 budget with 4% reduction, I see it as the County Manager's problem to implement.

On Tuesday, December 2, 2014 County Council looked at cuts on line items and gave suggestions for the County to tighten belts. Identification of unnecessary expenditures should continue.

Good Afternoon,

I had the opportunity to attend the recent PFM presentation for Luzerne County debt restructuring. A few days after the presentation, I had the opportunity to meet with Solicitor Pedri to discuss the options presented by PFM.

An article appeared in the Times Leader this morning and included the agenda for the County work session, scheduled for tomorrow evening.

Of paramount importance, will be a discussion of the options available to the County to refinance / restructure the \$88 million swap.

I have been in the investment business for over 29 years. I focus primarily on fixed income investments and have expertise in public finance.

I have had a few conversations with entities who invest in municipal bonds. Some focus only on Pennsylvania municipal bonds. I am quite confident there is an opportunity to save the county significant money short term and long term by exploring a private placement.

I would be happy to discuss some of the work that I have done on Luzerne County debt.

During my meeting with Soilcitor Pedri, I handed him a signed letter detailing my desire to volunteer my services to assist the County through this process. I am not interested in compensation in any way.

I am somewhat concerned about PFM's role as the financial advisor in this process. My personal view is County leadership should interview at least two other financial advisers to compete for this business.

I am writing as a private citizen...my firm or any individual or firm affiliated with me will not in any way participate in this proposed RFP.

While I am keenly aware of the time restrictions, I am quite sure as the current financial advisor, PFM could negotiate another short term extension until a permanent plan is in place.

I am not opposed to the retention of PFM as the County's financial advisor.

However, I am quite concerned that refinancing negotiations were not initiated well before the SNPA rate was ratcheted up from 25 basis points to approximately 3 % from late 2013 to date.

I am not interested in appearing at the public meeting to discuss my concerns. I do believe it would be beneficial discuss share some concepts and ideas for the benefit of Luzerne County.

ORDINANCE	

An Ordinance of the County of Luzerne Amending the Luzerne County Zoning Ordinance of 1964 to Provide for the Abatement of Nuisances Caused by Junk Vehicles

The purpose of this Ordinance is to amend the Luzerne County Zoning Ordinance of 1964 to prohibit the residents of the municipalities covered by the Zoning Ordinance from keeping junk automobiles or automobile parts on residential properties

BE IT HEREBY ENACTED AND ORDAINED by the County Council of Luzerne County, Pennsylvania as follows:

INCLUDE NEW SECTION 6.15 6.15 Luzerne County Junk Vehicle Abatement

The Luzerne County Council prohibits the storing of junk vehicles on private property that is visible from adjacent public and private properties that cause visual nuisances to the people on the adjacent properties.

A. Prohibited Conduct.

- 1. It is a public nuisance for any person to keep or store a junk vehicle or any type/ amount of automobile hulk in any district, where such vehicle(s), or parts thereof, are visible from public or private property within five hundred (500) feet of the junk vehicle(s). This does not include private property of the Owner or Landowner.
- 2. A junk vehicle or automobile hulk shall not be a nuisance if the junk vehicle or automobile hulk is stored in a garage or other walled, permanent structure and is visible only through a window or when a garage or other door is opened.
- 3. Exemptions. Persons operating properly licensed junk, wreckage and salvage yards for car parts, impound lots, or vehicle mechanic shops are exempt from this ordinance.

B. Complaint Process.

- 1. Any person who feels another person is in violation of this ordinance may contact the Division, in writing, by providing the address of the location of junk vehicles, or automobile hulk, and details of the junk vehicles and/ or automobile hulk.
- 2. Upon receipt of the complaint, the Administrator shall send out a person to inspect the property and alleged junk vehicles. The Inspector shall inquire as to the identity(ies) of the Landowner and Owner.

- 3. If, in the opinion of the Inspector and/ or the Administrator, the alleged junk vehicles, or the automobile hulk is/are nuisance(s) as defined by this ordinance the Division shall administer a written notice of abatement. Such notice shall be in a form decided by the Administrator and shall inform the Landowner and Owner of:
 - 1) The property declared a nuisance;
 - 2) The time period for abatement;
 - 3) Steps a person may take for abatement; and
 - 4) Penalty for failing to abate the nuisance within the allotted period of time.

C. Abatement.

- 1. A nuisance declared under this ordinance may be abated by any of the following methods:
 - a. Removal of the junk vehicles/ automobile hulk from the property.
 - i. The Landowner or Owner may make private arrangements for the removal of junk vehicles or automobile hulk.
 - ii. Third party contracted for abatement services:
 - a. The Administrator may make arrangements/ contract with any person to provide abatement services under this ordinance.
 - b.If the Administrator does contract with a person to provide abatement services, the Landowner or Owner may contact this person to remove any junk vehicles or automobile hulk and turn title over to that person at no expense to the Landowner or Owner.
 - b. Fixing/ use of the junk vehicles/ automobile hulk.
 - c. Storage of the junk vehicles or automobile hulk in a garage/ structure as referenced in Section 3(B).
- 2. Abatement must be completed within sixty (60) days of notice.

D. Penalties.

- 1. Failure of a Landowner or Owner to abate a declared nuisance within sixty (60) days of notice shall result in a weekly penalty of \$500.00 until the nuisance is abated.
- 2. Any time after the sixty (60) day period for abatement has passed, the Administrator may make arrangements for the abatement of junk vehicles or automobile hulk at the expense of the Landowner and Owner.
- 3. The maximum penalty for a single nuisance under this ordinance shall be \$2500.00.

AMEND ARTICLE 11- DEFINITIONS

The following definitions shall also be included in Article 11:

Abatement- means the correction of the condition in question by means established in Section 4 of this ordinance.

Administrator- means the Head of the Division of Operational Services for Luzerne County, or his/ her designee.

Automobile Hulk- means any and all parts of a vehicle, not attached thereto, including but not limited to, the body, engine and short blocks, frame, transmission or transfer cases, doors, bumpers, fenders or quarter panels, truck beds, seats, steering wheel, tires, rims, and hood.

Division- means the Division of Operational Services for Luzerne County.

Inspector- any designee by the Administrator to inspect/ inquire in junk vehicles and their ownership.

Junk Vehicle- means any vehicle (as defined by this section) that meets at least two (2) of the following criteria:

- i) Is ten (10) years or older;
- ii) Is extensively damaged, such damage including but not limited to: broken windows, missing tires and/ or rims, extensive rust damage, missing internal parts.
- iii) Is apparently inoperable;
- iv) A build-up of debris, vegetation, moss or weeds in/ on/ around the vehicle obstructing its use;
- v) Evidence that the vehicle has not been moved in 120 days.

Owner- means the record owner of the junk vehicle.

Person- means natural person, business partnership, corporation, or other organization.

Public Property- means to include any public sidewalks or roads in addition to land owned by any government entity.

Vehicle- means every device for transportation that is normally required to have an annual license and registration for operation on public roads, including, but not limited to, cars, trucks, motorcycles, buses, vans, scooters, and mopeds.

If the government commissioned a master plan for the conversion the property, I request that as well. I also ask for any past traffic studies involving the 315/115/309/81 exchange.
