Voter suppression in Luzerne County is real. Three of four Brannan votes did not count in the most recent special election. This scenario was 100% the result of Luzerne County Bureau of Elections' errors. We have the phone records and numerous emails, as well as discussion with Adam in the state department to prove it. Now? You, Ms. McBride.....no one in the administration will answer

OR CORRECT the errors. That is called **VOTER SUPPRESSION**. It affected BOTH parties.

Today is the RAISE grant deadline (February 28.). The residents of Luzerne County, in the majority, do not want the West Nanticoke Bridge to cost us 75 million dollars. You must submit a new list of road projects for the **ENTIRE** loan amount of 54.9 million dollars. Do not fail us again. Please.

I have been hospitalized in ICU but continue to watch council meetings and take the time to send you letters because I can not get to the podium. I asked that you answer my question regarding new projects for the 54.9 million-dollar loan at your last meeting and instead, you continued on to the next letter. Please answer my questions. Was it your intent to get to February 28 so the grant request could not be placed? Why not request for the Water Street bridge AND West Nanticoke bridge and hope you get ONE? ***You are wasting residents' money.***
