DEPARTMENTAL RECOMMENDATION:

The Community Development Office recommends that Luzerne County Council approve the addition of a second round of funds to the 2021 revenue and expense budgets for the Emergency Assistance Rental Program. This increase in revenue reflects funding received from the following agency:

U.S. Department of the Treasury \$2,993,485.44

SUMMARY:

This amendment is required to accurately reflect the increase in funding awarded by the U.S. Department of the Treasury for the Rental Assistance Program.

FINANCING:

Funding was awarded to Luzerne County to administer emergency rental assistance programs for local landlords and tenants.

DISCUSSION:

This program will provide much needed assistance to income eligible households for rent, utilities, and other expenses related to housing incurred due to Covid-19.

ALTERNATIVES:

Luzerne County Council may choose not to approve however, this is not recommended because it would deprive income eligible households and landlords the assistance they need to recover from the pandemic related emergency.

OTHER AGENCY INVOLVEMENT:

Luzerne County will enter into a sub-recipient agreement with the Commission on Economic Opportunity to administer the program with oversight performed by the Community Development Office.

ORDINANCE

*An Ordinance of County Council for the County of Luzerne
Amending the 2021 Fiscal Year Budgets for Luzerne County*

WHEREAS, the Luzerne County Administration received \$2,993,485.44 from the U.S Treasury for, the COVID-19 Emergency Rental Assistance Program round 2 to provide rental assistance for those who have been impacted due to the COVID-19 global pandemic; and

WHEREAS, pursuant to Section 5.07 of the Home Rule Charter of Luzerne County, County Council adopted the 2021 Fiscal Year Budgets which accounted for anticipated revenue and expenses;
and

WHEREAS, Section 5.10 of the Home Rule Charter States County Council may amend any of the budgets at any time during the fiscal year by ordinance adopted by an administrative vote of at least a majority plus one of its current members after a public hearing has been held; and

WHEREAS, County Council for Luzerne desires to amend the budget at the appropriate line items in order to account for the receipt of funds to the 2021 Fiscal Year budget.

WHEREAS, therefore, the following is hereby ENACTED AND ORDAINED by the Luzerne County Council:

SECTION ONE. Incorporation of Preamble.

The provisions set forth in the preamble to this ordinance are incorporated herein by reference in their entirety

SECTION TWO. Amendment of line in budget.

A public hearing having been held on _____ County Council hereby amends the following line items in the 2021 fiscal year budget in order to account for receipt of funds related to the COVID-19 Emergency Rental Assistance Program 2:

REVENUES:

Line Item- **140.20.4176.470.81** Emergency Rental Income 2 shall be increased by \$2,993,485.44

EXPENDITURES:

Line Item- **140.20.4176.599.81** Emergency Rental 2 shall be increased by \$2,993,485.44

SECTION THREE. Remainder of Budget.

All other items in the 2021 Fiscal Year Luzerne County Budget shall remain unchanged.

SECTION FOUR. Effective Date.

This Ordinance shall become effective fifteen (15) days after enactment.
