ORDINANCE

An Ordinance of County Council for the County of Luzerne Amending the Capital Plan Budget for Luzerne County

WHEREAS, Luzerne County Council adopted the 2022 Long-range Operational, Fiscal, and Capital Plan ("Capital Plan"); and

WHEREAS, Section 5.10.F. of the Home Rule Charter states County Council may amend any of the budgets at any time during the fiscal year by ordinance adopted by an affirmative vote of at least a majority plus one of its current members after a public hearing has been held; and

WHEREAS, County Council for Luzerne desires to amend the Capital Plan to deposit unencumbered funds in the amount of \$174,937.57 to line item 194.50.4315.445.10 to be utilized for future projects approved in accordance with the Luzerne County Home Rule Charter; and

WHEREAS, the aforesaid amount will be available for transfer into the Capital Plan upon payment of delinquent taxes by the Greater Wilkes-Barre Chamber of Business & Industry to Elite Revenue Services and Elite Revenue Services' subsequent payment of said funds to Luzerne County.

NOW, THEREFORE, the following is hereby ENACTED and ORDAINED by the Luzerne County Council:

SECTION ONE. Incorporation of Preamble.

The provisions set forth in the preamble to this Ordinance are incorporated herein by reference in their entirety.

SECTION TWO. Amendment of Capital Plan.

A public hearing having been held on ________, County Council hereby amends the 2022 Capital Plan to provide unencumbered funds to line item 194.50.4315.445.10 for future projects as approved in accordance with the Luzerne County Home Rule Charter in the amount of \$174,937.57 with said funds to be transferred into the Capital Plan upon payment of delinquent taxes by the Greater Wilkes-Barre Chamber of Business & Industry to Elite Revenue Services and Elite Revenue Services' subsequent payment of said funds to Luzerne County.

SECTION THREE. Remainder of Budget.

All other line items in the 2022 Luzerne County Long-range Operational, Fiscal, and Capital Plan shall remain unchanged.

SECTION FOUR. Effective Date.

This Ordinance shall become effective fifteen (15) days after enactment.
