March 3, 2004

On the above date at 10:00 A.M., the Luzerne County Board of Commissioners convened their regularly scheduled meeting with the following present: Gregory A. Skrepenak, Chairman; Todd A. Vonderheid and Stephen A. Urban, Commissioners; Samuel T. Guesto, County Manager for Legislation/Chief Clerk; Mark R. Dingman, County Manager for Administration/Deputy Chief Clerk, James Blaum, County Solicitor; Joseph Loftus-Vergari, Director of Human Services; James Miller, Administrator of Valley Crest; Michael L. Morreale, Treasurer; Stephen L. Flood, Controller; James J. Brozena, County Engineer; John J. Glushefski, Director of Road & Bridge; William P. Burke, Director of Property and Supply,; Adrian F. Merolli, Director of Planning; Sandra Russell, Director of Community Development; Salvadore Diaz, Chief of Budget and Finance.

Mr. Skrepenak called the meeting to order and asked everyone to join in saying the Pledge of Allegiance followed by a moment of Silent Prayer. It is noted that all meetings are electronically recorded.

Commissioner Skrepenak reviewed the protocol for Public Comment and directed Mr. Samuel Guesto, Chief Clerk, to ensure the five-minute time limit is adhered to.

PUBLIC COMMENT

Stephen Flood, Controller, provided comment on the hiring of a Telecommunications Assessment Consultant and expressed his concern in spending the County's money on recommendations such as this. He cited the Controller's office review of the five Telecommunication companies two years ago and the money saved. Further, he recommended the Commissioners try to accomplish these tasks with the use of the Row Officers and Department Heads.

Mr. Flood provided comment on the Resolution for Severance, citing the recent discussion of the past practice of \$3,000 in severance pay. He questioned if this applies to management or union employees; are the funds available to accomplish and if so, where; status on the plan to reduce the tax to 8.1 mills. Also, Mr. Flood addressed the majority Commissioners on the status of the injunction suit that was to be dropped. Commissioner Skrepenak responded that it has been brought to the Commissioners attention that they could bring suit against Schnader, Harrison, Segal and Lewis for the legal fees they have received because they were not properly retained. Mr. Flood asked who gave the majority Commissioners this advice. Attorney James Blaum responded the Counsel for the Injunction Action is on record as Attorneys John Moses and Chris Jones. Attorney Blaum further commented that he is recluse from this case due to conflict of interest. Mr. Flood questioned whether Commissioner Skrepenak has met with Attorney Moses. Commissioner Skrepenak responded that the bottom line is to protect the people of this County as best as possible. We are engaged with this firm and are further investigating the original agreement and trying to resolve the issue of retaining them on a contingency basis.

Mr. Flood questioned when the ARC payment would be paid citing a loss, an average of 20-30%, with the delay. Commissioner Skrepenak deferred the question to Salvadore Diaz who responded that the budget is being reviewed and could not provide an exact date at this time. Commissioner Vonderheid responded that the payments are included in the budget would be made as soon as possible.

Mr. Flood revisited the Valley Crest Separation pay, stating he would not pay the \$3,500 to each of these employees and questioned how the vacation and sick pay would be calculated and awarded.

Attorney Jason Matteroli, firm of Menora & Menora, hired by the concern of the taxpayers and pensioners of Luzerne County. Addressed issue to Commissioner Skrepenak, as of January 1, 2003 the pension fund have paid approximately \$500,000 to the Schnader firm for the representation of a certain legal matter under an existing contract. Under a new contract this firm will be retained on a contingency basis. The concern of the taxpayers is that since they have already lost \$17 million and do not want to lose another half million. They would like to have the contingency plan go into effect, however, they would like not one more penny spent and the \$500,000 reimbursed and put back into the fund before any new contract is put in place.

PUBLIC COMMENT: (cont.)

Commissioner Skrepenak acknowledged this is the concern of the majority Commissioners that neither group loses any money. He further added it should be a full contingency basis. The majority Commisserioners concerns are that have been addressed.

Commissioner Urban, addressing the attorney's concerns, Mr. Jones had filed an action with NASDA, 203million number in 1999. The fund went down consistently from 203 to 187 to 165 to 153 to 141 before the managers were changed. Number one Mr. Jones did not have permission from the Board of Commissioners to file that action with NASDA. He did have permission to file an action in the Court of Common Pleas and that is on record as of April 2, 2003. Nor did he bring that action to Commissioner Urban. Mr. Jones did submit a detailed bill and is named as a solicitor on particular items. I have a conflict of a loss of 17 million dollars and cited a chart that was presented to the Retirement Board and invited the attorney to the Retirement Board meeting at 1:00 PM. Mr. Flood commented referring to the Daily News, Philadelphia Enquirer or the New York Times everything is going along the same the RICO Act and the lawsuit that we have - we are spending \$500,000 to make \$75 million. The fund had made \$24 million since the majority took over the Retirement Board.

Arlene Holloway, Sugarloaf Township, provided comment on the proposed housing for the elderly and handicapped project. Ms. Holloway said she lives on East County Road, where the Luzerne Housing Authority wants to construct the Villas of Sugarloaf, a complex of 24, one-story, single homes. She said elderly people who would live there would have no common place to congregate unless they chose "to battle the elements" to visit with another resident.

Sandra Russell, Community Development Director responded that they are a funding agency and do not have anything to do with the controversy between the township and Housing Authority. Ms. Russell further explained there is nothing the housing for the elderly and handicapped regulations that precludes the authority from building single homes and these are not elderly care homes just a more innovation approach to it.

Commissioner Vonderheid commented that this Board's only charge is to the creation, appointments and dissolving of an authority like the Housing Authority. This Board needs to deliberate on making new appointments or making alterations on that Board and then address the problematic issues and the Commissioners have heard these issues and trying to address them as swiftly as possible.

Will Toole, Pittston, addressing Mr. Flood, questioned his relationship with Attorney Cullen and the two personal lawsuits he is representing for Mr. Flood. Is there a conflict of interest or was there was a special consideration provided him when he was retained by the Retirement Board. Mr. Flood responded he retained Mr. Cullen's services in September 2003 after the Board had already retained him.

Mr.; Toole also requested to see the contract and bill for the \$500,000. He questioned Mr. Flood if there was a contract in place when the Retirement Board authorized the payment of the \$500,000. Mr. Flood responded that there was and encouraged Mr. Toole to attend the Retirement Board meeting at 1:00 PM. Commissioner Skrepenak also extended the invitation to attend the meeting.

Mike Gotcha, Bear Creek Township, as a former public official, expressed his concerns regarding the youth of our County and available employment. He questioned the Commissioners as to what plans they may have in place or what intentions they have to resolve this issue. He cited his own children, graduating from college and having to go elsewhere to find affluent employment. He also questioned whether the Commissioners screen every applicant as he has become aware of individuals who have applied for positions and never received any notification as to whether their application had been received. Commissioner Vonderheid addressed the latter point citing the new Human Resource Officer will be in place next week and will organized a screening system to review all applicants and respond accordingly. Commissioner Vonderheid addressed Mr. Gotcha's concern on the retention of the youth in this County, noting the number one issue is to make this community one where people want to stay and make it grow. He added, the recent announcements of Fairchild Semiconductor and Tobyhanna for increased hirings. Commissioner Skrepenak concurred.

Tom Dombroski questioned if the company hired to do the Reassessment is the same as the company who did Alleghany County. Commissioner Urban responded no it is not the same. Mr. Dombroski provided comment on the Voluntary Separation pay stating that he does not believe people should be rewarded for leaving and cited the Controller's earlier comments.

PUBLIC COMMENT: (cont.)

Mr. Dombroski recommended Public Comment should be allowed during the Work Sessions and that may alleviate the longevity at the Commissioners' meeting. He provided comment on the right to comment on the "on the question" that the people should be allowed to comment not just the Commissioners. He recommended, if there is justification for consultants, they should be paid under the funding of the Community Development, which is 100%, funded.

Attorney Blaum respectively disagreed with Mr. Dombroski's recommendation for the "on the question" explaining that once the Board entertains a motion and a second, then it appropriate for debate of the Board members, under the Public Comment section of the agenda it the proper time for the public to respond. Commissioner Skrepenak noted that there are now work sessions prior to the Commissioners meeting that are open to the public and press something that has not been done in the past. Ms. Kamp requested that possibly the work session be changed to 10:00 am to make it more convenient and accessible to the public. Commissioner Skrepenak responded the Commissioners would investigate the possibility.

Robert Reilly, Clerk of Courts, for the record, introduced himself and provided his background. Mr. Reilly clarified that he did not previously speak with the Commissioners prior to the last meeting and was present at no one's request. He acknowledged, very proudly, that Commissioner Skrepenak is his cousin and that Commissioner Vonderheid is a friend, however that does not influence his choice to speak. He credited Commissioner Skrepenak for his acknowledgement of Sam Hyder as a friend and noted that other relationships may have been taken into consideration for appointments to Boards and Authorities. Mr. Reilly congratulated the Board on the progress that has been made in the first 60 days. Mr. Reilly provided comment on the phone system, the AOPC are going to come in June with the new computer system and start the implementation of the new system in September. The letter states that their office must have Verizon. Commissioner Vonderheid commented there are three phases to the RFP and that the second part is to understand the state mandates that are required and relate to IT. Mr. Reilly encouraged the Commissioners and Row Officers to forego the badgering as it affects everyone.

Mr. Toole, with permission from Commissioner Skrepenak, after some skepticism, applauded the majority Commissioners on their decision to hire Sam Hyder, as he has heard nothing but positive things since his appointment.
