On the above date at 10:00 A.M., the Luzerne County Board of Commissioners convened their regularly scheduled meeting with the following present: Gregory A. Skrepenak, Chairman; Todd A. Vonderheid and Stephen A. Urban, Commissioners; Samuel T. Guesto, County Manager for Legislation/Chief Clerk; Mark R. Dingman, County Manager for Administration/Deputy Chief Clerk, James Blaum, County Solicitor; Joseph Loftus-Vergari, Director of Human Services; James Miller, Administrator of Valley Crest; Stephen L. Flood, Controller; James J. Brozena, County Engineer; John J. Glushefski, Director of Road & Bridge; William P. Burke, Director of Property and Supply,; Adrian F. Merolli, Director of Planning; Andy Reilly, Deputy Director of Community Development; Salvadore Diaz, Chief of Budget and Finance.

Mr. Skrepenak called the meeting to order and asked everyone to join in saying the Pledge of Allegiance followed by a moment of Silent Prayer. It is noted that all meetings are electronically recorded.

Mr. Flood announced bids are open in the Treasurers' Office.

Commissioner Skrepenak reviewed the protocol for Public Comment and directed Mr. Samuel Guesto, Chief Clerk, to ensure the five-minute time limit is adhered to.

Commissioner Skrepenak introduced Kathy Bozinski and Samuel Guesto for the presentation of the Proclamations.

Mr. Williams presented the Community Progress Award to the Board of Commissioners and Adrian Merroli, Director, Luzerne County Planning Commission.

Kathy Bozinski introduced Virginia Augello, Director, Tax Claim Bureau, to provide an account of the events which transpired which led to the Board of Commissioners recognizing the following employees with County Proclamations in their honor. Two weeks ago, Stewart Bender, Tax Claim Bureau employee, suffered a heart attack while at work. He was found lying on the floor; his face was blue and no pulse. Nadine Price called 911, Cathy Schappert, assisted by Beth Ann Christian, and administered CPR. David Roberts, Prothonotary's office, a trained first responder, rushed downstairs to assist Ms. Schappert to help resuscitate Mr. Bender twice. Paramedics arrived and transported Mr. Bender to the hospital where he subsequently recovered and returned to work this week. Other tax Claim employees cleared out boxes and files to make way for the paramedics while others escorted customers out of the office in calm, polite manner. Mr. Bender stated "I want to thank God for giving everybody the ability to save my life, I'm glad to be here."

Commissioner Skrepenak, on behalf of the Commissioners, congratulated each of employees and expressed admiration of these individuals in saving a life noting no words could express. He congratulated Stewart Bender on his recovery and welcomed him back. Finally, Commissioner Skrepenak commented on situations such as this demonstrates the caliber of individuals the County has working for them.

Tom Williams, Greater Wilkes-Barre Chamber of Business and Industry, on behalf the organization's Government Affairs Committee, congratulated the Luzerne County Board of Commissioners for winning the Chamber's "Community Progress Award" for the recently adopted Luzerne-Lackawanna Open Space, Greenway and Outdoor Recreation Master Plan. Mr. Williams commented the Board of Commissioners should be commended for their vision and commitment to regionalism with this Open Space Plan, which is the first multi-county plan in the Commonwealth. This proactive effort, to achieve a balance between the natural environment and business development, will preserve the excellent Quality of Life enjoyed by the citizens of Northeastern Pennsylvania.

Mr. Williams presented the Community Progress Award to the Board of Commissioners and Adrian Merroli, Director, Luzerne County Planning Commission.

Commissioner Skrepenak added that most of the credit goes to the previous administration including Commissioner Urban for their efforts in making this project happen.

Commissioner Skrepenak reminded everyone that if you wish to address the Commissioners to see Ms. Bozinski and sign in.

PUBLIC COMMENT

Christine Katsock, Wilkes-Barre, publicly thanked Commissioners Skrepenak and Vonderheid for their involvement and support of the Colleen Shea Foundation Spring Fundraiser coming up next month. Ms. Shea was Ms. Kat sock's cousin and she personally appreciates the Commissioners for their willingness to take on this cause, noting Ms. Shea had a great love of children and with the support of this foundation it will continue. Commissioner Skrepenak commented he personally knew Ms. Shea and she was a wonderful person.

Ms. Katsock commented on the upcoming decisions of the Economic Development County money that would to be decided shortly and that projects were going to be ranked on their viability. Ms. Katsock offered her support for the Steam Heat Plant Project and its viability, citing the amount of new jobs it will bring to area, the quality and pay scale of those jobs, the opportunity to bring major corporations into the area through broadband, as well as the private entity money that has been provided for this project. Ms. Katsock urged the Commissioners, with the Governor visiting this week, for their great support for this project. Commissioner Skrepenak offering his support of the project further commented that although they would like to do everything, the Commissioners must to prioritize so they do not overlook anything. Commissioner Urban commented that he also supports this project. He noted that he has been to several meetings on this project and recollected the Governor's visit last year at the Woodland's and that the topic was discussed with the Governor and Councilman McCarthy of Wilkes-Barre City who was present to offer his strong support. Commissioner Urban further commented that if you want to build a business park, part of the infrastructure is putting the roads in, the phone lines and the utilities that are needed. If you want to bring in high tech jobs into the area, part of the process is having that high tech infrastructure - broadband, fiber optic communications infrastructure. Without such infrastructure he does not believe you can accomplish this. A project like this is the start of such a process and has his full support.

PUBLIC COMMENT: (cont.)

Carl Goodwin, Kingston Township, provided comment on the structure of the Commissioners' staff, referencing it as a million dollar staff, hired to do the work for the Majority Commissioners and leaving a trail of red ink in the County Treasury, referring to the Ordinances related to Budget and Financing and the Administrative Code. He noted that the Personal Policy would be adopted by Resolution not Ordinance. He expressed his dismay at this intention, noting he saw no stability in doing so, citing that if it is passed by Resolution, the Commissioners can change it at will at any meeting. And he found that is a direct conflict with the resolution passed by the Board of Commissioners at its January meeting. Mr. Goodwin, referring to the paragraph under Professional Services, specifically the language on advertising "time to time" as a loophole and would like to confirm if this is an attempt to protect one its biggest supporters. Mr. Goodwin also questioned which one of the Commissioners would be appointed to sit on the Greater Wilkes-Barre Chamber of Business and Industry Board. Commissioner Vonderheid responded he was appointed to that Board. Commissioner Skrepenak responded that there would be changes to the Administrative Code that will be announced by Mr. Guesto. Referring to the Personnel Policy, the reason the policy is not in place today, our Personnel person was not hired in time to put this into place within the first one hundred days. The Commissioners are moving slowly and deliberately to allow for the Department Heads and Row Offices to be consulted and there are no mistakes. The reason this policy is being passed as a Resolution is because we not want to handicap anyone that may come in after this administration and also allow this policy to change and grow with the times. As a Resolution, we will be afforded the opportunity to review the policy annually and make adjustments as necessary. Commissioner Skrepenak questioned Mr. Goodwin as to why he always directs his concerns to Commissioner Urban. Commissioner Urban responded Mr. Goodwin contacted the office requesting a copy of the Resolution and Atty. Blaum met him in the hall and Mr. Goodwin let him know he was there to see Commissioner Urban. Yesterday he asked for a copy of the original resolution to compare to what was in the Ordinance. Commissioner Urban further commented that Mr. Goodwin is a citizen like anyone else and has rights like any other citizen and should not be criticized for coming here and trying to make positive changes. Commissioner Urban expressed his concern of this Ordinance having any teeth and by teeth he was referring to penalties, such as monetary fines, for not following the rules. He further noted after reviewing the Ordinance he believe that the original resolution requested three separate Ordinances, Administrative, Personnel and Budget Process. When the Ordinance was presented, the he contacted the papers after they had contacted him earlier that day. Commissioner Urban added he would and will continue to be responsive to anyone who contacts him and as a citizen, Mr.. Goodwin has a right be here and bring things to the Commissioners' attention. He believes the newspaper item Mr. Goodwin brought to their attention was definitely worthwhile. Mr. Goodwin commented that the Ordinance is a direct retreat from your contract with the People of Luzerne County. Commissioner Skrepenak responded that in no way was he discouraging Mr. Goodwin from coming to see the Commissioner. He questioned that the document on the agenda was made public a week ago, and questioned why Mr. Goodwin did not come into the office sometime between then and prior to today's meeting and allow all three of the Commissioners to address those concerns. Commissioner Skrepenak added he would consider making the Personal Policy into an Ordinance, noting however, you can change an Ordinance with a little more effort than a Resolution and it is going to be at the mercy of the Commissioners and the administration that they serve. He added that they were trying to ensure the Commissioners would revisit the Personnel Policy when the administration reorganizes at the beginning of the year to ensure the policy is the best policy for this County.

Commissioner Vonderheid responded to the phrase "time to time" explaining this was meant to allow for some creativity on behalf of the newspapers so they may put together a package of their rates. He noted they want to encourage competition by packaging the rates. He referred to the last sentence of that clause where it states all advertising will be done at the lowest rate provided. Adding, that since this administration has taken office all classified ads have been placed in all three newspapers. Mr. Goodwin pointed out that the second sentence contains a major loophole that states the County reserves the right to use one or more newspapers, which could allow for a monopoly on County advertising by one of your biggest political supporters. Commissioner Vonderheid responded this allows for those, such as the large percentage of readers in the southern part of Luzerne County, whose newspaper might not win a package deal to still have the right to the information ensuring everyone is as informed as possible. Mr. Goodwin suggested it should be changed to any newspaper at any time could submit a proposal for advertising, but the way it is presently written, it does not provide that opportunity.

PUBLIC COMMENT: (cont.)

Mary Kamp, questioned the need for the eleven or twelve new appointments under the Human Services Department agenda and how this reflects the Commissioners commitment to trim County Government. Commissioner Skrepenak deferred the question to Mr. Joe Loftus-Vergari, Director, Human Services. Mr. Loftus-Vergari responded his Department is state and federal funded, supervised County managed system and they, the State and Federal, provide the funding, therefore requiring our agencies to provide the service or man the positions. Commissioner Vonderheid responded they will be doing their best to trim the numbers of full time employees, however, that does not mean it will be across the board, in fact some departments that have very little resources, such as the Human Services Department who are saving lives everyday are not the places to trim. Caseworkers and social workers are not the place to trim from this County Government it is a place, which needs to be empowered. Commissioner Skrepenak revisited the handicap parking issue brought up at the last meeting by Ms. Kamp and confirmed with Mr. Jim Brozena, County Engineer, that the rear of the building handicap parking area should be reopen by the end of May. Commissioner Urban commented on the parking for the public at Penn Place and noted with the movement of Tax Claim and the Treasurer Departments to Penn Place it will be a greater issue for adequate parking and believes a set number of spaces be available for the public. Commissioner Urban also recommended that the closet spots across the street from the Courthouse should be made available to the public and the reserved spots moved to the parking garage and believes this should be addressed as soon as possible. Adding he spoke to the Redevelopment Authority and John Glushefski concerning parking at Penn Place and the Authority owns land, the second track along Northampton Street, where quite a few number of spaces could be built for long term parking for the employees of Penn Place and the Authority is willing to work with the Commissioners.

Mr. Stephen Flood provided comment on a bill from Attorney Christopher Jones, the Special Counsel for former Commissioners Makowski and Pizano who was hired in February 2003 for approximately \$35,600. Upon review of the bill, a memo is included from Atty. Jim Blaum stating that immediate payment should be made. Atty. Jones received a \$10,000 retainer back in February to review the Merrill Lynch problems but it appears the billing is for work outside of his retention agreement and appears to include defending former Commissioners Makowski and Pizano, Jones and Crossin. In reviewing the billing sheet. Mr. Flood cited several items that did not appear to relate to the Merrill Lynch case but defense for the former majority Commissioners. Atty. Blaum referred to a retention letter of engagement, authorized by the former commissioners, Makowksi and Pizano, which outlined the scope of work, which included representing the County in any matter involving the Retirement Board. He added part of any attorney's scope of work is to gather information and evidence from witnesses to better their case, which is what the items are reflecting. Mr. Flood questioned whether Atty. Blaum was representing the defendants in the RICO matter. Atty. Blaum referred that this matter was addressed at a previous meeting, adding, Atty.. Jones was hired as a special solicitor to the Board of Commissioners. Atty. Blaum reviewed the letter of engagement with Mr. Flood. Atty. Blaum clarified that the bill being discussed is not \$35,600 but \$25,602.99. Mr. Flood read a memo from February 13th approving this bill and questioned the County Solicitor's authority to approve this bill. Atty. Blaum responded it has been the practice of his office to review all legal bills and approve, noting bills have been forwarded to his office from Dave Murowski, Deputy Controller, requesting such approval. Mr. Flood recommended, in light of the questions surrounding this bill, the Commissioners not pay the bill until independent counsel reviews it. Mr. Flood requested the Commissioners vote on the payment of this bill, as he will not pay it without their approval. Atty. Blaum advised the Board they do not have to vote for an individual bill but so that the matter does not go forward, noting he was going to request authorization to institute legal action to compel payment of this bill, recommended the Commissioners do so. Atty. Blaum strongly recommended that a motion be made concerning the payment of this bill. Atty. Blaum also noted that Mr. Flood did not make any objection within the time frame called for by the Code, which was relevant to his authority. Mr. Flood countered he did make several requests including the receipts to support the bill. Atty. Blaum commented that numerous billings have been processed and there has never been a request such as those related to this particular billing. Commissioner Urban reflected on Atty. Blaum's statement that Atty. Jones was retained as counsel to represent the Board of Commissioners. Commissioner Urban stated this order was issued before it was voted on by the Board and he had no knowledge before coming in here. This action was taken on February 5, 2003, when there was a vote taken that Atty. Jones was hired and what he was going to do. Commissioner Urban, despite several attempts, requested Atty. Jones brief him on what he was doing and/or provide him with any information.

PUBLIC COMMENT: (cont.)

He has seen Atty. Jones demonstrate his working for the Board of Commissioners, noting Atty. Jones has never sat down with the Commissioners in an Executive Session. Commissioner Urban stated he gave Atty. Jones a copy of the order from Judge Olszewski, stating that he was to be informed of any Executive Sessions and any violation of this order would be seen as contempt. Atty. Blaum responded that he personally knows of no Executive Sessions between Atty. Jones and the former Commissioners. Commissioner Urban cited several items on the bill and there relation to what Atty. Jones was hired to do. Atty. Blaum explained that legal actions are very complex and attorneys will seek information and evidence relevant to the matter before the court. Everything listed on the bill is related to the Retirement Board, which is included in the letter of engagement. Commissioner Urban commented on an article saying that the reason this bill was so high was because Atty. Jones had to prepare a NASD submission and noted that Atty. Jones never came to the Board for their approval to do this and secondly, the NASD item is listed on the bill as one hour. One of the problems, the Commissioner stated, is Atty. Jones is not laying out the facts, isolating only certain facts. His facts seem to present only what Mr. Jones wants to present not all the facts and without a vote of the Board. Commissioner Urban questioned if Atty. Jones is signing on behalf of the Board of Commissioners and there have been no meetings, does he have the authority to file any motion he wants because he is hired as special counsel? Commissioner Skrepenak requested Atty. Blaum to set up a meeting with Atty. Jones and have an Executive Session to clear this matter. Commissioner Urban questioned who gave Atty. Jones authority to file the second contempt charge against Mr. Flood for simply coming to a meeting. Atty. Blaum responded that when you hire an attorney to represent you and do his or her best effort in a particular matter, the attorney does not have to necessarily come to the client for every correspondence or filing. Commissioner Urban responded on a defense he is in an agreement as the attorney is out to defend, but if he is initiating new actions hi does not agree. Atty. Blaum responded that it was not a new action and was under the same docket number. Commissioner Skrepenak reminded the Board that Atty. Cullen has made new numerous filings without the acknowledgement of the Board. Commissioner Urban responded that is because Mr. Jones is defending not initiating actions and there is a difference. Atty. Blaum responded that Atty. Jones is willing to enter into a straight contingent fee agreement on the NASD matter. Commissioner Skrepenak responded the Commissioners will revisit this issue and everything will be taken under consideration.

Tom Dombroski, Kingston Township, provided comment hat one of the reasons he has offered his assistance on the work sessions to Mr. Samuel Guesto, Jr., was to get rid of situations like this. Mr. Dombroski complimented Mr. Guesto on his efforts. He also complimented Mr. Brozena for his efforts and working with him with regards to additional funding. Mr. Dombroski expressed his disappointment on a response to his questions directed to Mr. Jim Miller and the consultants for Valley Crest. He also referenced the article on Mr. Fischi and the Prison Budget, citing that the figures are not correct and he would be willing to meet with Mr. Salvadore Diaz, Chief of Budget and Finance, to go over these numbers. In regards to the matter just discussed, he recommended they go back to the Retirement Board and work on it there. He complimented the current administration for listening and taking the time to consider recommendations. Commissioner Skrepenak responded the Commissioners are reviewing Valley Crest and will be hiring a consultant. In regards to Gene Fischi, he believed Mr. Dombroski was referring to the overtime analysis. Mark Dingman responded Mr. Diaz would be working with the Warden to go over the figures to ensure the accuracy. Commissioner Skrepenak commented that he spoke to Mr. Guesto regarding the changes to the work session and Mr. Guesto has implemented several of those changes Mr. Dombroski had recommended. Commissioner Urban agreed there are discrepancies with the overtime analysis and it did not appear to include the financial impact of benefits.

Mr. Guesto responded to that he had a copy of the new work session format recommended by Mr. Dombroski.

Mr. Guesto announce two Executive Sessions held one on April 7, 2004 for Personnel Issues and one on April 19, 2004 for Personnel Issues.

Commissioner Urban commented that last week people of Hazleton chartered a bus and went down to meet with Rep. Eachus who in turn took everyone to meet with the Governor, but due to a scheduling conflict they met with representatives of the Governor's office. Commissioner Urban reported he and three Hazleton residents are scheduled to meet with Rep. Eachus and the Governor's Chief of Staff to address issues they have before them.

It was moved by Commissioner Urban, seconded by Commissioner Urban.

Request a Motion to adopt an Ordinance establishing an Administrative Code and Operational Structure, a Purchasing Manual, a Budget and Finance Code and authorizing creation of a Personnel Policy for the County of Luzerne, effective April 21, 2004 noting the following changes since it's public release on April 14, 2004.

- 1) Page #22: Senior Reporting Chart slight change to more clearly illustrate the relationship between the Chief of Budget & Finance and the other Division Chiefs.
- 2) Page #23: Organizational Chart The addition of the "Women's Commission" to the Department List, instead of its listing to the Advisory Boards, Councils and Commissions box.
- 3) Page # 23 Organizational Chart The addition of the Valley Crest Advisory Board in the Advisory Boards, Councils and Commissions box.
- 4) Page #37: Purchasing Code the addition of the following in Section 3:13.1 "(10) Those related to professional services involving professional expertise that are to be provided to customers of a County program or initiative where the following applies: (i) the costs of the services are to paid, or reimbursed to the County, from state or federal funds (ii) the service provider has been pre-approved by the state or federal government as an authorized service provider for such services and (iii) the customer has chosen the service provider from a list of pre-approved service providers.

This section has been added to allow federally and state funded county agencies/programs to allow for mandated "customer choice" of service providers.

5) Page #37 & 38: Purchasing Code – the correction of Section 3:14.2. Change from 3:132 Professional Services Prior to the award of any contract that is more than \$7,500 and that is exempted from bidding pursuant to Sections 3:13.1 (5) to "3:13.2 Professional Services Prior to the award of any contract that is more than \$7,500 and that is exempted form bidding pursuant to Sections 3:13.1(7), 3:13.1(8) and 3:13.1(9). This exclusion in the 4/14/04 version was a simple typo.

Commissioner Urban commented he revisited what was said in January 2004 which stated there would be three (3) separate ordinances, (1) Administrative Code, (2) Personnel, and (3) Budget and Finance. Had that been accomplished he would have supported the Budget and Finance Ordinance today and the limited Personnel Policy, as he believed the Commissioners are committed to implementing a Personnel Policy. Commissioner Urban stated he would not support the administrative Code as he did not see consolidation taking place in the sub sections of the county and does not see any spelling out of that being done. Took departments and put them under the head of a new manager. In the public, he hears complaints that the County has a million dollar staff and hasn't done much to consolidate the sub elements in County Government and eliminate middle managers that are needed in departments. Because of that and the fact that it is package together he cannot support adding another million dollars of overhead. One of the reasons he did not support Home Rule because it created a big staff without consolidating functions there were also several other reasons including that the legislative districts were democrat and there probably would have been a Democrat as Executive and it would have been a one party rule. The Administrative Code creates high-level positions without the consolidation of functions within those departments and without cutting expenditures he will not support it because it is package. He noted that he does support bidding out services and we just need to better of writing specifications outlining what we want. Commissioner Skrepenak questioned Commissioner Urban to clarify how the Administrative section relates to consolidation. Commissioner Urban responded that big staff positions and place individuals under those individuals but there is no indication of consolidation. The real issue is new positions have been created and moved individual department heads under those managers but nothing has been done to consolidate within those departments. He has not seen those savings outlined in January 2004. Commissioner Skrepenak responded his perspective provides a clear chain of command, a process which will allow the Commissioners to consolidated the departments when it examine what needs to be done. He added this document provides the foundation to build a better structure for Luzerne County and eventually realize those savings. Commissioner Vonderheid commented that he understands Commissioner Urban's concerns with consolidation of departments. That is the entire intent the creation of these positions happened on January 6, 2004 at the Salary Board meeting. What happens today is the clear delineation of powers and authorities of those positions. We have taken ninety odd units of government including Boards and authorities and created 9 operating divisions. We have reporting systems and enable consolidation of departments. Jennifer Learn-Andes, the Times Leader, questioned the right sizing of Valley Crest and what is the next step after the Voluntary Layoff Progam was completed. Commissioner Skrepenak responded that based on those earmarked who chose the Voluntary Layoff Program, which Mr. Miller responded were about half, will define the next step. Commissioner Urban questioned Mr. Miller as to what the end number, after all proposed positions are eliminated. Mr. Miller responded the total number of employees will be fewer than three hundred. Commissioner Skrepenak questioned what is the current census. Mr. Miller responded the current number is 192 and the projected was 210 for the first quarter. Commissioner Urban requested Mr. Miller provide the details of what will be done with the Budget to compensate for the shortfall.

COMMISSIONER'S COMMENTS

Commissioner Urban provided comment on the Administrative Code noting that Commissioner Vonderheid was correct when he referenced the Salary Board approval in January 2004, but noted he was not in favor of some of those positions. He further commented that there is a good dialogue with the Departments and Managers and added he was pleased with last month's Retirement Board meeting and the receipt of the ARC payment.

Commissioner Vonderheid commented he was delighted to be part of a Board that has created the first real level of rules and regulations in Luzerne County History. He added the purchasing policy is stronger that what is required by the Commonwealth of Pennsylvania and an amazing Budget Ordinance that starts with why and not how much. Commissioner Vonderheid explained the first step of the budget process is for the Department Heads to define goals and objectives and provide a narrative interpretation of what each department is doing an why they are asking for money which allows this Board to make those decisions based on the overall goals and objectives of County government. He congratulated Mr. Diaz for drafting this Ordinance and is proud to have voted for it. Commissioner Vondereheid commented he looks forward to working with Kimberli Weiland in drafting a Personnel Policy. Finally, he added, he was pleased to acknowledge the retaining of Kimball and Associates, hired to do a long-term assessment of the overall corrections system noting this is a big step in the right direction.

Commissioner Skrepenak echoed Commissioner Vonderheid's sentiments. He commented that there is no items on the Salary Board Agenda but understood that Commissioner Urban and Mr. Flood would be accompanying Mr. Brozena on a tour today to understand the necessity and salary requirements of the two levee electrician positions that will proposed shortly.

A Motion was entertained to adjourn the Commissioners' Meeting.
