**PUBLIC COMMENT**

Tim Grier, Wilkes-Barre, voiced his concerns on how Wilkes-Barre City is, in his opinion, misspending funding from federal, state and local entities. He requested the Board, on behalf of the County, cease any funding and/or forgiveness of taxes on behalf of the City of Wilkes-Barre until such a time as they, the City, can provide details on how the money is really being spent. Mr. Grier recommended that the funds should be released to the residents of Wilkes-Barre who wish to improve their properties.

Richard Ashton, Wilkes-Barre; Jim Spak, Ashley; and Carl Olshefski, Askam; provided comment on the removal of trees along the Susquehanna River levee from the county courthouse to South Street and requested the Board of Commissioners halt the project.

James Brozena, County Engineer, referred to a 2003 study recommending the removal of 74 dead or decaying trees. Adding the tree removal is the start of the \$23 million River Common project in the city which will include multiple construction projects. Mr. Brozena added the tree-removal plan was based on arborist Vincent Cotrone’s 2003 analysis of 154 trees along the levee. According to the study, impending construction would cause root damage to 35 cherry trees near the levee, and most of the cherry trees are in poor condition. Finally, Mr. Brozena stated when the project is complete about 50 trees will be left standing, and 250 new trees will be planted and the plan also includes planting 500 shrubs and 10,000 perennials and bulbs and adding 50,000 pieces of ground cover.

Commissioner Vonderheid added Mr. Cotrone “the greatest advocate of trees in Northeast Pennsylvania” and said “the project is proceeding” after six years of public discussion and planning.
