Commissioner Urban questioned whether the contract may violate the county's purchasing policy, which requires any work costing more than \$7,500 to be advertised. Commissioner Urban also commented taxpayer funds are being used to pay the contract with OneSource Staffing Solutions and the names should be released. Commissioner Urban said he could not support this motion due to these questions and concerns.

Commissioner Skrepenak requested Chief Solicitor Jim Blaum to research whether the County would violate any laws by releasing the names of the employees brought back to ensure the county would not be exposed to a potential lawsuit by releasing the names.
