BID OPENINGS

There are no bid openings.

PUBLIC COMMENT

George Hayden, Jr., Hazleton, provided comment on the Broad Street Corridor Project stating that it is vital to our area. It will bring more people downtown; it will bring more people throughout Hazleton and through our community and of course, Luzerne County. But, again, as a taxpayer, as a building owner, as a business owner, I would like to continue making this process moving as quickly as possible so we can continue our good growth for Hazleton.

Thomas Yurick, West Hazleton, delivered a petition with 2, 201 signatures against the Broad Street Corridor Project. This isn't just resurfacing; it is a major undertaking that is literally gutting the community. Changes being made will be irreversible. The families are going to be effected. People who are involved with this don't live here, they are insensitive to the issue. The majority of the people who own business in West Hazleton are saying 'no'. The Commissioners should follow the instructions of the people and that's what this petition signifies.

Bill Spear, Hazleton, voiced his support for the Broad Street Corridor Project. He provided comment on the safety issues including; pedestrian lights, traffic lights, turn only lanes, lighting, uprooted trees, and sidewalks. This project gives us a once in a lifetime opportunity. Other cities have done it and Hazleton deserves to do it too.

Jason Misto, Bottleneck Saloon and Eatery in West Hazleton voiced his support of the Broad Street Corridor Project, stating that there are more businesses than residences. His family has spent \$30,000 on improvements on their building along with just about everybody on the street. He would like the rest of Broad Street updated and to stay with the times.

Don Elko, Covenant Abstract in West Hazleton, stated he is strongly in favor of this. He is in favor of any project that will better West Hazleton. All of Broad Street desperately needs this.

Jim Christman, West Hazleton, provided comment on the Broad Street Corridor Project stating that he is a 50 year resident and his family are life long residents of Hazleton. This project is long over due, this is a good second step. The first step of work on Broad Street and Diamond Avenue resulted in better and safer traffic flow. Mr. Christman asked that these worthwhile projects move forward. He left eight letters of support from businesses on Broad Street and read from some of them.

Carol Kay, Hazleton Senior Center, thanked the Commissioners for having meetings in Hazlton and provided comment on support for the Broad Street Corridor Project; stating that the new lights, street lights will be wonderful and she will not have to worry about the seniors when they go on the streets.

James Flame, West Hazleton, represents a group of West Hazleton residents that support the Broad Street Corridor Project. He stated that business will be better after the project is completed. He asked that this project move forward as planned.

Bill Bauer, Hazleton, CEO for Hazleton General Hospital, strongly supports the Broad Street Corridor Project stating safety issues are a main concern.

Gary Damish, Hazleton, provided comment on traveling through West Hazleton and the safety issues. The Broad Street Corridor Project is already paid for and will unite two communities, so we can all be very proud of Southern Luzerne County.

Ann Marie Shelby, Hazle Township provided comment on the dredge, fly ash and air quality in Luzerne County. She also provided comment that the traffic lights be controlled instead of widening Broad Street.

Susan Bartholomew-Palmer, Wilkes-Barre, provided comment and questioned legal issues regarding guardianship of her brother. She also believes that many people in Luzerne County are being held in the system against their will for the sole purpose of individuals within county government to extort their assets from them. After explanation and discussion, Ms. Bartholomew-Palmer was instructed that she would need to go to the Court System to pursue this matter.




