

**DECEMBER 10, 2009**

On the above date at 3:00 P.M., the Luzerne County Board of Commissioners convened a meeting with the following present: Maryanne Petrilla, Chairman; Gregory Skrepenak, Commissioner; Stephen Urban, Commissioner; Douglas Pape, Chief Clerk/County Manager; Vito DeLuca, County Solicitor; Tom Pribula, Chief of Budget and Finance; Dominic DePolo, Deputy Treasurer; Joseph DeVizia, Human Services; Joseph Gibbons, County Engineer; Andrew Reilly, Office of Community Development; Frank Pugliese, Jr., Director of Purchasing; Adrian Merolli, Planning Commission.

Maryanne Petrilla called the meeting to order and asked everyone to join in saying the Pledge of Allegiance. Commissioner Petrilla asked for a moment of silence for the troops who will not be with us this holiday season.

**PUBLIC COMMENT:**

**Thomas Concert:**

Thomas Concert expressed his concerns and frustrations in regard to the child care services provided by Luzerne County. Mr. Concert stated that he has been intimidated and retaliated against by these agencies for speaking up in trying to have his children returned.

Commissioner Petrilla stated that this Board of Commissioners did not have the power or authority to address Mr. Concert’s problem. Commissioner Petrilla stated that it was a situation that the commissioners legally could not get involved in. Commissioner Petrilla informed Mr. Concert that this problem must be handled by the courts.

Mr. Concert stated that he was still seeking the whereabouts of his children He stated that county government was there to help him. He stated that he has been speaking with the Director of HHR and trying to move forward. Mr. Concert stated that he felt people were impairing the director from doing the quality of work he is capable of.

Mr. Concert commented on the testimony that Commissioner Petrilla and Commissioner Urban provided to the Inter Branch Commission. Mr. Concert stated that there would be perjury allegations once the transcripts form the proceedings come out. Mr. Concert stated that the commissioners were asked if they were aware of any problems going on in the child care agencies and they replied no. Commissioner Petrilla cautioned Mr. Concert on the accusations he was making.

Mr. Concert stated that the county has all the resources but they are not complying with the policies. Mr. Concert stated that his children needed to be returned. Commissioner Petrilla responded that the commissioners did not have the authority to return his children.

Mr. Concert provided a letter to each commissioner.

Commissioner Urban asked Mr. DeVizia if the commissioners have impaired him in any way from doing his job. Mr. DeVizia replied no.

**Wil Toole:**

Wil Toole provided a handout to the commissioners listing some fiscal suggestions. Mr. Toole stated it was time for the commissioners to think outside the box. Mr. Toole suggested that the county form a committee of businessmen to help with some of the problems in the county instead of hiring consultants.

Mr. Toole provided comment on county employees giving up one day a month. Mr. Toole stated that it would be a 5% cut in pay, in which some employees could not afford. Mr. Toole stated that he could not see how the unions in the county would go along with this idea. Mr. Toole stated the 5% pay cut would amount to \$2 million dollars, which was the exact amount he asked the commissioners to try and recoup from the law firm of Schnader, Harrison, Segal, and Lewis. Commissioner Petrilla responded that the \$2 million dollars was a retirement issue. Mr. Toole responded if the county received the \$2 million back from the firm that would be \$2 million less coming from the general fund to the retirement account at the end of the year.

Mr. Toole reviewed a cost saving plan of home confinement of non violent inmates compared to incarceration. Mr. Toole stated the county could save up to \$3 million dollars a year with this program.

Mr. Toole suggested that the county institute a policy for tax appeals by allowing property owners to submit appraisals prepared by state certified appraisers. The taxpayers would not have to take time off from work to attend the hearing or pay any additional fees for the appeal process.

Mr. Toole ended by asking the commissioners to consider these suggestions.

**Ed Chesnovitch:**

Ed Chesnovitch provided comment on a home in Jackson Township. Mr. Chesnovitch stated the owner of the home is paying \$10,000 less this year in taxes due to the reassessment. Mr. Chesnovitch stated it was a \$17 million dollar property, which included the land, assessed for \$2 million dollars. Mr. Chesnovitch stated he was told by the Assessors Office that they could not look at the property because it could be considered spot looking and they can run the risk of being sued. The owner bought additional land around the property which amounted to \$700,000. He stated that the appraised value of this land was \$2,500. This would amount to the county and municipality receiving \$12.68 a year in taxes. Mr. Chesnovitch questioned how you can take nineteen acres in a prime location valued at \$540,000, then put it in Clean & Green and make it \$75,000. Mr. Chesnovitch questioned if the commissioners had any authority over the Assessors.

Commissioner Petrilla stated that the Assessment Office reports to the Board of Assessment.

Mr. Chesnovitch asked if the commissioners could direct someone to go out to the property and have it properly assessed.

Commissioner Urban asked the county solicitor to look into the law regarding this issue. Commissioner Urban stated there are instances where commissioners or any taxing body can vote to look at a property.

Vito DeLuca responded he thought the taxing body would make a determination as to whether or not an assessment on a certain property is not in line of what it should be. Just as a taxpayer could appeal the taxing body could as well.

Commissioner Skrepenak stated he was under the impression that the county cannot request that. He stated that the school boards and municipalities can but he didn't believe that the county could. He stated that research has been done on the matter. He stated the county does not have any oversight other than budgeting or hiring their employees. He stated that the tax assessors certify the tax rolls then the commissioners put it in the millage. He stated that they are governed by the Board of Appeals.

Mr. DeLuca stated it was his position to request that the Board of Assessment Appeals look into the matter.

Mr. Chesnovitch questioned the proposed tax increase. Mr. Pribula stated the proposed millage increase was 18.5%.

Commissioner Petrilla stated today's vote is to just get the budget on display. The actual budget and approval of the budget will not happen until December 30<sup>th</sup>. The law allows us a 10% fluctuation on what is on display today to the actual vote on December 30<sup>th</sup>. Commissioner Petrilla stated this could change up to \$12 to \$13 million dollars. Commissioner Petrilla stated any action today does not increase your taxes.

Mr. Chesnovitch stated that the county is looking at 8% or 28%. Mr. Chesnovitch stated that he hoped his concerns would be addressed. He finished by stating he informed the commissioners in the beginning that the reassessment was a flawed process.

**TIF Amendment –Highland Park Boulevard**

Request a Motion of the Luzerne County Board of Commissioners to amend the Cooperation Agreement dated November 6, 1998 for development of Highland Park Boulevard. The amendment calls for the Wilkes-Barre Area School District to contribute an additional \$3,000,000 for the Coal Street phase of the project. This amendment has already been approved by the City of Wilkes-Barre, the Wilkes-Barre Area School District, Wilkes-Barre Twp., and the Luzerne County Redevelopment Authority.

Doug Pape asked Bill Vinsko from the City of Wilkes Barre to explain this request.

Mr. Vinsko explained: The city entered into a TIF Financing program in 1998 for the Highland Park Boulevard Development. The City of Wilkes Barre is now completing that part of the development into Coal Street for its widening project. Both the Wilkes Barre Area School District and Luzerne County provided money for the project. What you are voting on now is an amendment to the TIF agreement. The Wilkes Barre Area School District has offered to pay \$3 million dollars to complete this project. What they asked for in return was an agreement that they will not be asked for any more funds. Once approved, the school district will release the funds in increments of \$1 million dollars a year for the next three years, the first one being this week.

Mr. Pape questioned if the county was the last entity to approve this.

Mr. Vinsko stated yes, the school district approved it in early November, the Luzerne County Redevelopment Authority on November 26<sup>th</sup> or 27<sup>th</sup>, Wilkes Barre City approved it last week, and Wilkes Barre Twp. has dropped out of the TIF because they have completed their portion.

Commissioner Skrepenak questioned when the TIF was expected to be done. Mr. Vinsko stated the financing will be complete in 2011.

Commissioner Urban stated that he spoke with Mr. Kratz at the Redevelopment Authority and was told this TIF would not increase any costs to the county. Commissioner Urban questioned if this was correct. Mr. Vinsko stated that was correct. Commissioner Urban questioned if additional costs would be the city's responsibility. Mr. Vinsko replied any additional costs would be the city's issue at this time. Mr. Vinsko stated it was his understanding that the funding by Luzerne County had been completed some time ago. By this amendment any additional funding would come from the school district. Luzerne County has no liability going forward. Commissioner Urban stated he wanted it on record that the county has no liability. This is an agreement in which the school district will pay \$3 million dollars and any additional funding will come from the city. Mr. Vinsko replied that Mr. Urban was correct. Commissioner Urban stated it was his understanding that this TIF has three years remaining on it, according to Mr. Kratz he has enough funds sitting in an account at the bank to payoff the TIF. The only issue that remains is the unresolved right away purchases that Pen Dot is still negotiating to payoff owners of land that were previously condemned where the exit of Highland Blvd. was put in place. Mr. Vinsko stated Mr. Urban was correct. He stated that they met yesterday on those issues and they are getting close. The legal descriptions have been completed and now it's just a matter of closing the deals on all of them.

Adrian Merolli from the Planning Commission stated he was involved in the original TIF for this project. Over the years Mr. Merolli stated the Wilkes Barre School District had not been putting in their share of the tax revenues. Mr. Merolli asked Mr. Vinsko if this \$3 million dollars is over and above what they are

supposed to pay or is it in place of what they were to pay. Mr. Vinsko stated it was his understanding it was over and above what they were suppose to pay. He stated he was not involved in the original drafting of the amendment but it was his understanding through conversations that at this time this \$3 million was agreed upon and they felt they had already maxed their portion of the TIF and had agreed to proceed.

Commissioner Urban asked Mr. Merolli if they should research this further before a vote was taken. Mr. Merolli stated that they need to look and see if this is in place of what was not paid in or is this in excess. Mr. Merolli stated they were also looking for an accounting going back to Commissioners Pizano and Makowski. He stated the county was remitting their tax revenues however there was an impasse with the Wilkes Barre School District putting in their share.

Commissioner Petrilla stated this action is not going to cost the county any more money.

Mr. Merolli stated that was correct, but the original document has the school district listed for a certain amount of money. Mr. Merolli again questioned if this was lowering the amount or increasing it based on what they haven't paid over the past years.

Commissioner Urban stated it was his understanding that the school district had not paid. He asked if this was the school district anteing up the \$3 million and that's all they will ante up in the future. Commissioner Urban stated that the total cost for the PennDot legal fees are not known at this point in time. Commissioner Urban asked if the city was willing to go on record stating they will pay the difference.

Mr. Vinsko stated the amendment is to confirm that the school district and the county are essentially out at this point. In regard to the accounting issue Mr. Vinsko stated he would be glad to contact someone at the school district for that information.

Commissioner Urban stated the motion reads "contribute an additional" \$3 million which he takes to be over and above what their obligation is under the TIF.

Mr. Vinsko stated it was his understanding that this \$3 million is the final amount being paid by the school district.

Commissioner Urban asked that this motion be tabled until the next scheduled commissioners meeting.

Commissioner Petrilla stated a motion was on the table.

#### **Doe v Luzerne Settlement Agreement**

"Request a Motion to authorize proper County officials to execute settlement agreement on the case of Doe v. Luzerne County, et. al. No County funds will be paid out."

It was moved by Commissioner Urban, seconded by Commissioner Petrilla

Mr. Pape asked Tom Pribula, the Budget Director, to review the proposed 2010 budget.

Mr. Pribula stated the following: There are probably 8 to 10 variations of this budget worked on since the end of July. We need to have the budget displayed for 20 days so we can continue to do county business and get a tax anticipation note in January. We have the latitude to adjust this budget by a 10% aggregate or about \$12.7 million dollars. In summary the budget we are looking to propose is \$127.2 million dollars. Originally county departments submitted an amount of \$141.1 million, so we have chopped it down to \$13.9 million or 10% over what the departments originally requested. Over 2009 we are down 1.6% or \$2 million dollars. We are finally moving in the right direction. The biggest positive of this budget is there is no additional debt, no new debt, or refinancing of debt. The negative of this budget is a tax increase. In this budget there is a .8368 millage increase which equates to 18.5%. The 2009 budget is a good one and

we are projecting a \$4.6 million cash balance carry over. We made great strides between 2008 and 2009. In closing this is a \$127.2 million budget with no additional debt. We are asking to have it displayed for twenty days, in which we will continue to work on it.

Commissioner Petrilla clarified that this motion was not saying any commissioner is in favor of a tax increase or closing any departments. It is a working document to be displayed for twenty days. The law allows us to fluctuate the numbers by 10% so we can go \$12 million up or down without violating any law.

Commissioner Urban questioned if the 10% fluctuation was in the county code.

Solicitor DeLuca read from the county code section 1782.

Commissioner Urban stated that he thought the budget still needed work to reduce spending. He questioned whether the county needed full time tip staff positions in the courts. Commissioner Urban suggested that the county sell Valley Crest and their interest in the baseball team. He stated he was in favor of a 24 day furlough and he asked that the unions cooperate with the commissioners. Commissioner Urban commented on the 911 department stating not all three shifts have to be staffed with the same man power because the workload is not the same. Commissioner Urban stated he would vote to put the budget on the table but he would not vote for a tax increase. He stated he would vote to shut the place down on December 30<sup>th</sup> if we don't have a budget that makes sense or spending cuts necessary to move the county forward.

Commissioner Petrilla thanked Commissioner Urban for his willingness to put the budget on display.

Commissioner Petrilla implored the two commissioners to work with them on the budget. She stated that they have spent countless hours working on a budget that is real, with real alternatives. She went on to state that they need real solutions. The administrations of the past have brought us to this point. There has been reckless overspending and over borrowing that has put the county in debt for \$466 million dollars. She stated that no one wanted a tax increase but she as a leader in this county has to make reasonable choices. I need the commissioners to come to the table with real solutions and real answers, not fictitious revenues. She commented on the ridiculous, fictitious revenues that were in this county and never came to fruition, which has put us in this spot today. I cannot in good faith let it continue. I'm thrilled that the budget is on display for the public to see but the excessive borrowing and spending has put us where we are today. If the commissioners are against a tax increase I respect that whole heartedly. The county lowered taxes six years ago and had we not done that we would have \$18.5 million dollars right now to work with. Those irresponsible actions of previous boards of commissioners are why we are here today. I refuse to continue to make irresponsible actions. I hope that the commissioners will come to work and sit down with us and get this budget to where it's real and something we can live with. If we continue to put in fictitious revenues, next October we will be up the creek again. It's fiscally irresponsible and I implore you to realize the seriousness of adopting a budget that is realistic.
