

**MARCH 24, 2009**

On the above date at 1:00 P.M. the Luzerne County Board of Commissioners convened a Salary Board Meeting with the following present: Maryanne Petrilla, Chairman; Gregory Skrepenak, Commissioner; Stephen Urban, Commissioner; Anthony Martinelli, Acting Controller; President Judge Chester Muroski, Douglas Pape, County Manager for Legislation/Chief Clerk; Vito DeLuca County Solicitor

**CALL TO ORDER:..... Maryanne C. Petrilla, Chairman**

**PUBLIC COMMENT:**

Walter Griffith stated that he just received a copy of the salary board agenda. He stated that he was concerned as to whether all the board members had time to review the agenda before the meeting.

Commissioner Petrilla responded that the agenda had been available for thirty minutes prior to the meeting. She stated if people came in they would have had the opportunity to review it.

Mr. Griffith stated that there was a lot of information listed on the agenda and he was concerned about not being able to address these items because he was not aware of what was listed on the agenda.

Commissioner Petrilla responded that not a lot has changed since budget time. She stated that the same long book that was available to the public and published in the newspaper was being finalized today.

Mr. Griffith questioned if any positions were created in the Probation Department.

Commissioner Petrilla responded that positions were created and others were eliminated to try and become more consistent in the county and have one job description.

Mr. Griffith stated that his concern was that the meeting was scheduled and advertised in advance so why wasn't the agenda available sooner so it could be reviewed by the public.

Commissioner Petrilla responded that they were working with the courts to get within the budget items as to where they needed to be dollar wise. Commissioner Petrilla stated that the courts were completely in charge as to who they hired or furloughed to be in compliance with the budget. Commissioner Petrilla stated that no one was being hired as a result of today's actions. She stated that they were cleaning up job titles and setting salaries as was approved in the budget.

Mr. Griffith commented that the county code states the President Judge needs to be present to vote at the meeting. He questioned whether Mr. Mulroy could vote at this meeting. Mr. Griffith also stated that the Acting Controller is not a member of the Salary Board.

Commissioner Petrilla responded that Mr. Martinelli had taken an oath of office the day he became Deputy Controller to act on behalf of the Controller in his/her absence.

Mr. Griffith responded that the county code stated that the Treasurer will cast a vote if the Controller is not available.

Commissioner Petrilla responded that AJ was designated by the Governor as Acting Controller. She stated that they received a letter from the Governor stating he was not going to name a Controller because there was a Deputy who was acting as Controller.

Vito DeLuca stated that Mr. Martinelli is the Acting Controller and has taken on those responsibilities of the position. Mr. DeLuca stated that he did not believe they were violating the county code.

Mr. Griffith questioned whether the President Judge needed to be present for the vote.

Mr. DeLuca responded that in the past the judges have sent a designee to vote on their behalf. He stated that he wasn't aware that Judge Muroski was not going to be at the meeting. He stated that the code does state that the President Judge will have a vote on the Salary Board.

Commissioner Petrilla stated Mr. McGarry represented the courts at other Salary Board Meetings.

Mr. Griffith stated that the Salary Board was a five member panel. He stated if the President Judge was not present that would make it a four member panel. Mr. Griffith stated that the law states Mr. Mulroy cannot vote. Mr. Griffith commented that he was only trying to make sure there were no improprieties on the Salary Board.

Commissioner Petrilla stated that she took full responsibility for the Judge not being present. Commissioner Petrilla stated that they met with the President Judge late yesterday and he informed them that he had a scheduling conflict. Commissioner Petrilla stated that she informed the Judge that in the past the President Judge would send a designee.

Commissioner Petrilla called a recess until the President Judge arrived.

Commissioner Petrilla called the meeting back to order.

Commissioner Urban stated that he didn't believe he should have been taken off of the Election Board. He stated that he could not find anything in the law that stated there was a conflict. Commissioner Urban stated that he was not going to vote to pay someone \$3,000 to attend three meetings.

President Judge Muroski stated that the Election Board Solicitor came forward and brought it to the court's attention. He stated that they moved on the motion made to them by the Election Board Solicitor.

Commissioner Petrilla questioned whether the members would serve through the fall.

Commissioner Urban responded no.

Commissioner Skrepenak questioned if the members were paid during the years that the Commissioners did not sit on the Election Board.

Commissioner Urban responded one year they were paid and the other year they were not paid.

President Judge Muroski stated that he would make a determination with the people appointed that they will serve at the same fee in the fall.

Commissioner Urban responded that there should be no fall election. He stated there was nothing on the ballot in the fall.

Commissioner Skrepenak stated that seventeen new positions were being created and only four were being eliminated. Commissioner Skrepenak questioned where there was a savings and where would the funding come from for these positions.

Commissioner Petrilla stated that there were no changes to the approved budget.

Commissioner Skrepenak stated that the seventeen positions being created did not add up to the positions being eliminated. He questioned where the money was being absorbed.

President Judge Muroski stated that ten vacancies have not been filled and the courts are currently down two judges.

Commissioner Skrepenak stated that he thought the Salary Board was moving away from salary ranges because it would eliminate the need for future Salary Board meetings.

Commissioner Petrilla stated while meeting with the judge they set up some salary ranges to be consistent with other ranges in the county. Commissioner Petrilla stated that some positions are strictly court positions.

President Judge Muroski stated that the courts worked within the budget figures that were requested by the Commissioners by moving positions around and changing salaries. President Judge Muroski stated that the courts had done everything requested of them by the County Commissioners.

Commissioner Skrepenak stated that he was trying to maintain consistency not only in the courts but the entire county. He stated that salary ranges have been eliminated.

Commissioner Urban stated that he didn't care for salary ranges. He commented that he was looking at an Executive Secretary position with a salary range of \$35,000 to \$50,000. Commissioner Urban stated that a sitting Row Officer gets an annual salary of \$36,000 and a sitting Commissioner a salary of \$42,000. He questioned whether a secretary does more work than a sitting Commissioner. Commissioner Urban stated that he just hired an Executive Assistant for \$35,000.

President Judge Muroski stated that he understood the Commissioners' position and he too felt that County Commissioners were underpaid.

He stated his salary is \$24,000 in one function and he had a contract with the county, in which he didn't feel was appropriate for a court employee, not to exceed \$4,000 per month. Judge Muroski stated the salary amount requested was the total of those two amounts combined.

Commissioner Urban questioned whether he would have a contract with the county anymore.

Judge Muroski stated, no. He would be a full time county employee.
