Vito DeLuca stated that it was his impression that they needed to reaffirm the positions, however the reality is that the county code requires that the only time Salary Board action is required is when a position is eliminated or a salary is amended or changed. Mr. DeLuca stated that it was not a bad idea to have a complete listing of every single position in the county. He stated that he didn't believe Salary Board action is necessary on an annual basis to reaffirm a position that was already created. Mr. DeLuca stated that one of the issues the administration had was there was no Personnel Director and the county was caught short handed at a very pivotal time with budget issues as well as preparing for this Salary Board meeting. Typically the Personnel Director would compile this data. Last year we re-affirmed all the salaries because it hadn't been done in years. This year that is not necessary. The only thing necessary is to do the added or deleted positions or where salaries have changed. Mr. Griffith stated that he was concerned because this should have been done the first Monday in January. Mr. Griffith commented that the Warden's salary has been reduced so he has been overpaid since January 4th through January 15th. Commissioner Petrilla responded that the Warden's salary has not been changed. She stated that last year there were twenty seven pays, this year it has been changed back to twenty six pays. Commissioner Petrilla stated that the Board is now changing all the salaries back to twenty six pays. Walter Griffith stated that he was concerned because the names were not on the list. Commissioner Petrilla stated that they were voting on the positions not the people. Mr. Griffith stated that he couldn't clarify the positions if he didn't have the name.
