Dear Captain Blake:

Thank you for writing to Luzerne County with your request for information pursuant to the Pennsylvania Right-To-Know law. Please note that I am the Open Records Officer for Luzerne County. My email is Jackie.Carroll@luzernecounty.org.

On August 23, 2017, the Luzerne County 911 received a request for documents from you described in the attached Right to Know request. Your request is granted and denied.

It is granted in that a search of the address at 35 Cherokee Drive, Union Twp., Shickshinny, PA was conducted by 911. The records are attached.

Further, 911 also searched the name "Trevor James Adams" and "Trevor Adams" and that name did not appear in any CAD Data by Luzerne County 911 Communications Center.

The request is denied in that if any of the reported calls resulted in action by the local police department or Pennsylvania State Police, the records would not be kept by Luzerne County. You would need to contact those departments to further investigate any calls that were received by 911.

Luzerne County does not maintain the records requested by you, therefore, your request is denied pursuant to §705 of the RTKL. §705 of the RTKL states that "when responding to a request for access, an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner in which the agency does not currently compile, maintain, format or organize the record".

This letter is a formal request made under the Georgia Open Records Act (O.C.G.A. 50-18-70) to obtain access to and permission to copy certain records in your offices.

I am conducting a background investigation on Trevor James Adams for potential employment with our agency. Mr. Adams indicated on his application that he lived at 35 Cherokee Drive in Shickshinny, PA since January 2007. I am requesting a 911 records search of his name and address to see if there have been any prior calls for service. If records are found, I would like to know the nature and outcome of the calls.

We are prepared to pay reasonable search and retrieval fees if necessary. Should your estimate of those fees exceed \$25.00, please advise me of the costs before they are incurred.

If my request is denied in whole or in part, we ask that you justify all deletions by reference to specific exemptions of the Georgia Open Records Act. I will also expect you to release all segregable portions of otherwise exempt material.

Please feel free to call me if you have any questions about this request. I look forward to hearing from you within three days in accordance with the Act.
