Thank you for your concern regarding the posting of the newly amended Bylaws on which you and your committee worked so diligently prior to their adoption by Council.

The marked-up version of the bylaws that was presented to Council for passage was prepared by the Solicitor's Office at the direction of the Bylaws Committee, and was presented in that form so that Council members could clearly see what was being amended. Following the adoption of the Bylaws, the Solicitor's office was tasked with providing an official version with changes incorporated.

Please note that it was at my direction, following my conversation with the County Solicitor, that the Bylaws are being reviewed by the Solicitor's Office prior to publication. As soon as the Solicitor has completed her review, the new version will be posted to the website.
