Some first thoughts about refining the County Council By-Laws....

1. I think swearing-in appointees to ABC's would be wise. It creates an opportunity to stress that the appointees are to make decisions in the best interests of the citizens and the future of Luzerne County. However, it probably makes sense for that provision to be treated as an amendment to Section 2.10 of the Administrative Code rather than codified in the By-Laws.

It may make sense to add language to Rule 12 C (1) of the By-Laws regarding this.

2. Rule 1B (3) regarding absent and not tardy. I think we should discuss and decide if that rule should clearly state whether the council member who is declared absent can vote at the meeting.

3. Rule 1D regarding Telephone...appearance. I think we should discuss this.
