Mr. McGinley,

I note that the process and timeline for filling the Council vacancy was discussed on the work session last evening.

This should have been voted on for Council approval during the voting session at the time when the vacancy was declared, not unilaterally implemented at the Chair's direction.

Particularly during the summer months, when many people have scheduled time away from home, implementing a process that requires applications to be received within 10 days of the discussion - not approval - of the process appears hasty, especially given the introduction of an ordinance last night that, if passed, will affect the qualifications of applicants.

I ask you to defer the implementation of this plan and timeline until it is approved by Council at a regularly scheduled voting meeting.
