Dear Ms. Laura Dennis:

Under the Pennsylvania Right to Know Law, 65 §66.1 et seq., I am requesting an opportunity to inspect or obtain copies of public records. Specifically:

- Copies of all currently active contracts (including any term and conditions incorporated by reference) with election system vendors, including contracts in effect related to the sale, maintenance and updating of election systems (i.e. voting machines, voting systems, electronic pollbooks, and ballot printing software).
- Copies of all promotional, marketing, and sales literature provided by election system (i.e. voting machines, voting systems, electronic pollbooks, and ballot printing software) vendors
- Copies of all technical specifications and manuals provided by election system (i.e. voting machines, voting systems, electronic pollbooks, and ballot printing software) vendors about the systems and system components that are the subject of the currently active contracts.

If there are any fees for searching or copying these records, please inform me if the cost will exceed \$100. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of advancing the public's understanding of election system functionality and for

purposes of enhancing my educational experience in a technology law class at Penn State Law taught by Prof. Andrea Matwyshyn. This information is not being sought for commercial purposes.

The Pennsylvania Right to Know Law requires a response time within five business days. If access to the records I am requesting will take longer than this amount of time, please contact me with information about when I might expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
