**ORDINANCE**

AN ORDINANCE OF THE COUNTY OF LUZERNE COUNTY COUNCIL AMENDING THE ADMINISTRATIVE CODE AT **SECTION 2.10 - LUZERNE COUNTY AUTHORITIES, BOARDS AND COMMISSIONS**

**WHEREAS**, Luzerne County is a Third Class County in the Commonwealth of Pennsylvania governed by a Home Rule Charter that became effective January 2012; and

**WHEREAS**, the Luzerne County Home Rule Charter at Article VI requires that an Administrative Code be established that sets forth a plan for the organization, administrative structure, procedures, and operations of Luzerne County government; and

**WHEREAS**, on June 19, 2012, the County Council passed Ordinance 2012-5, which adopted an Administrative Code with an effective date of July 19, 2012; and

**WHEREAS**, Section 6:02 of the Charter states; “County Council may amend the Administrative Code by ordinance”; and

**WHEREAS**, Section 2.10 of the Administrative Code deals with the regulation and operation of all Authorities Boards and Commissions;

**NOW, THEREFORE**, be it ordained and enacted by the Luzerne County Council by the authority of the same as follows:

**The Luzerne County Council hereby directs that Section 2.10 of the Luzerne County Administrative Code be amended to add the following item:**

**SECTION ONE: Adding (H) to Section 2:10 of the Administrative Code**

**H. Any persons appointed by the Luzerne County Council to serve on any County Authority, Board or Commission shall not receive any type of compensation, pension or other benefit for their service during or after their term of service.**

**SECTION TWO: Effective Date**

**This Ordinance shall become effective on the fifteen (15) day following its enactment by County Council.**

**SECTION THREE: Repealer**

**Any Resolution or Ordinance or parts thereof that conflict with or are inconsistent with this ordinance are hereby repealed to the extent of the conflict or inconsistency with this ordinance.**
