Thank you for writing to Luzerne County with your request for information pursuant to the Pennsylvania Right- To-Know law ("RTKL").

Recently, the Luzerne County Office of Law received a request for documents from you in a Right To Know request. Your request is partially granted and partially denied as set forth below.

Section 705 of the RTKL states: "When responding to a request, the agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner in which the agency does not currently compile, maintain, format or organize the record." Luzerne County does not have the ability to generate a report containing every item listed on your request; however, a report was generated by the Human Resources Department containing as much of the requested information as possible.
