

**RESOLUTION R-2021-106  
LUZERNE COUNTY COUNCIL**

*A Resolution of Luzerne County Council Approving a Budget Transfer  
Of Funds Within the Long-Range Operational Fiscal and Capital Plan Budget for the  
Purpose of Repairs at the Luzerne County Correctional Facility*

WHEREAS, the Luzerne County Manager submitted the 2021 Long-range Operational, Fiscal, and Capital Plan to Luzerne County Council (“Capital Plan”); and

WHEREAS, Section 5.10.E. of the Home Rule Charter states at any time during the fiscal year, County Council may, by resolution adopted by an affirmative vote of at least a majority of its current members, make transfers of part or all of any unencumbered balance from any division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function to any other division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function; and

WHEREAS, County Council for Luzerne desires to amend the Capital Plan to transfer unencumbered capital funds in the amount of \$50,000.00 to line item 194.50.4315.550.15 to be utilized for necessary repairs at the main building of the Luzerne County Correctional Facility; and

WHEREAS, the aforesaid amount is available and unencumbered in the aforesaid Capital Plan.

NOW, THEREFORE, be it RESOLVED by the Luzerne County Council:

**SECTION ONE. Incorporation of Preamble.**

The provisions set forth in the preamble to this Resolution are incorporated herein by reference in their entirety.

**SECTION TWO. Transfer of Funds Between Budget Line Items.**

County Council hereby authorizes the transfer of funds between line items in the 2021 Capital Plan in order to transfer unencumbered capital funds to line item 194.50.4315.550.15 for necessary repairs at the main building of the Luzerne County Correctional Facility in the amount of \$50,000.

**SECTION THREE. Remainder of Budget.**

All other line items in the 2021 Fiscal Year Luzerne County Budget shall remain unchanged.

**SECTION FOUR. Effective Date.**


This Resolution shall become effective immediately.


