

**RESOLUTION R-2021-108
LUZERNE COUNTY COUNCIL**

*A Resolution of Luzerne County Council Approving a Budget Transfer
to Cover Costs for Advertising for the Manager Search Committee*

WHEREAS, Luzerne County Manager C. David Pedri submitted his resignation effective July 6, 2021; and

WHEREAS, the Luzerne County Home Rule Charter at section 4.02 requires County Council to appoint a Search Committee to search for, screen, interview and recommend the most qualified candidates to County Council for final selection and appointment of a full-time County Manager; and

WHEREAS, County Council incurred expenses when it advertised for applicants for the County Manager Search Committee; and

WHEREAS, pursuant to Section 5.07 of the Home Rule Charter of Luzerne County, County Council adopted the 2021 Fiscal Year Budget which accounted for anticipated revenue and expenses; and

WHEREAS, Section 5.10.E. of the Home Rule Charter states at any time during the fiscal year, County Council may, by resolution adopted by an affirmative vote of at least a majority of its current members, make transfers of part or all of any unencumbered balance from any division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function to any other division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function; and

WHEREAS, County Council for Luzerne desires to transfer funds in the budget at the appropriate line items in order to transfer funds from the Reserve Fund to the Advertising Expense line item cover the advertising expenses incurred when County Council advertised for applicants for the County Manager Search Committee.

NOW, THEREFORE, be it RESOLVED by the Luzerne County Council:

SECTION ONE. Incorporation of Preamble.

The provisions set forth in the preamble to this Resolution are incorporated herein by reference in their entirety.

SECTION TWO. Transfer of Funds Between Budget Line Items.

County Council hereby transfers funds between the following line items in the 2021 fiscal year budget in order to transfer funds from the Reserve Fund to the Advertising Expense line item in order to cover expenses incurred in the advertising for applicants for the County Manager Search Committee:

Subtract funds from the Reserve Fund at line item 100.99.4940.585.10 in the amount of \$2,500.00.

Add funds to the Advertising Expense line item of 100.10.4111.550.30 in the amount of \$2,500.00.

SECTION THREE. Remainder of Budget.

All other line items in the 2021 Fiscal Year Luzerne County Budget shall remain unchanged.

SECTION FOUR. Effective Date.


This Resolution shall become effective immediately.


