Intercounty Transfer Guidelines

Due to COVID-19, processing and acceptance of transfer-in cases from other jurisdictions may be delayed. All cases received within the guidelines below will be reviewed. Please note that supervision and contact strategies are modified and subject to additional change(s) due to COVID-19 protocols.

Adult Probation & Parole currently accepts supervision of *all offenders who reside in Luzerne County*. Sentences transferred must have six (6) months of supervision remaining, but those already under our supervision will be given special/priority consideration for acceptance. In addition to regular probation and parole matters, the Department accepts ARD supervision. Cases to be supervised by specialty courts (treatment/mental health) must be coordinated by the Court Coordinator.

Offenders with supervision that requires house arrest with electronic monitoring (EM) must meet specific conditions for acceptance and for continued supervision:

- Residence must be located within Luzerne County.
- Residence must have electricity.
- Payment in full for the costs of the first 30 days of EM *or* the total amount due if less than 30 days of EM is ordered.
- Payment in full for EM at the start of each month, and for each subsequent month of supervision, is required for continued supervision.
 - **Radio Frequency (RF) monitoring is \$11.00 per day.**
 - Prepayment for RF is \$330.00 for acceptance, and \$330.00 at the beginning of each additional 30-day period. There must be electricity in the residence.
 - **GPS tracking/monitoring is \$12.00 per day.**
 - Prepayment for GPS is \$360.00 for acceptance, and \$360.00 at the beginning of each additional 30-day period. There must be electricity in the residence.
 - **Alcohol monitoring is \$12.00 per day.**
 - Prepayment for GPS is \$360.00 for acceptance, and \$360.00 at the beginning of each additional 30-day period. There must be electricity in the residence.
 - **Alcohol & RF monitoring is \$14.00 per day.**
 - Prepayment for dual monitoring is \$420.00 for acceptance, and \$420.00 at the beginning of each additional 30-day period.
- Lower Court/sentences issued by Magisterial District Court are NOT accepted from EM supervision.
- Offenders subject to EM will be removed from EM and their supervision will be rejected and returned for failure to pay for electronic monitoring.
