Dear James,

This is a request under the Pennsylvania Right to Know Law sometimes referred to as the Freedom of Information Act.

I request a certified copy of the following documents:

1. Current Oath of Office document and no older than 10 years.
2. Copy of your Foreign Agent Registration document.
3. A copy of your current bond including the issuing company name and address.

This is public information that I am requesting form you as a Public Servant in the post of Prothonotary. The Federal law for this request is under the Freedom of Information Act (5 U.S.C. 552) and the Department's FOIA Guide and rules at 28 CFR 16.1 et seq., and or Pennsylvania Right To Know Law enactment act of Feb. 14 2008 P.L. 6, no. 3.

Your failure to respond / provide this information constitutes that you have not taken an oath of office, have not register as a foreign agent, acquired a bond for the office you assumed on your own or by your employer. Your failure to respond is your admission that you failed to fulfill the Federal and or State Constitutional law, statue and or codes. Such as the County Code, the Act of Aug. 9, 1955 P.L. 323, No. 130 and Luzerne County Home Rule Charter all require the completion of these tasks. You cannot assume the public post of Prothonotary without the completion of all three.

Your silence in this matter is your admission to the fact that you have not complete anyone or more of the items listed above. Your silence on anyone or more of these items states that you have been masquerading / impersonating as a public servant in the post of Prothonotary, which is a fraudulent activity on your part. You have 30 calendar days from the date of this FOIA to respond. If you feel that, you need more time you have 15 calendar days from the date of this letter to make a written request for an extension of time in writing.

Thank you for writing to Luzerne County with your request for information pursuant to the Pennsylvania Right- To-Know law ("RTKL").

Recently, the Luzerne County Office of Law received a request for documents from you described in the attached Right To Know request. Your request is denied because Luzerne County does not maintain these documents. §705 of the RTKL states that "when responding to a request for access, an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner in which the agency does not currently compile, maintain, format or organize the record".

Please note Mr. Haddock is not an elected official and therefore does not require an Oath of Office. We do not have any foreign agent registration information. Finally, Bonds are on file in Luzerne County in the Prothonotary's Office and cover a variety of officials and positions. There is not one bond specific to Mr. Haddock.

You have a right to appeal this denial of information in writing to Executive Director, Office of Open Records, Commonwealth Keystone Building, 400 North Street, 4<sup>th</sup> Floor, Harrisburg, PA 17120.

If you choose to file an appeal, you must do so within 15 business days of the mailing date of the agency's response. Section 1101. If you have further questions, please contact Laura C. Dennis. Please be advised that this correspondence will serve to close this record with our office as permitted by law.
