This is a request under the Pennsylvania Right to Know Law, which almost mirrors the Federal Freedom of Information Act. Provide a complete answer to each question below.

I request a certified copy of the following documents:

1. Current Oath of Office
2. A copy of your current bond including the issuing company name and address.
3. I request a certified copy of the wording used and date the Pennsylvania Supreme Court or the United States Supreme Court vetted the following statutes as being Constitutional and Constitutionally enforceable.
  - a. Pa. C.S. Property Tax Title 68 real and personal property sec 2117, 3103, 2303
  - b. Public School Code of 1949 Act of Mar. 10, 1949, P.L. 30, No. 14 School Sec 602, 605, 652, 662, 672, 674, 676, 681,
  - c. 53 Pa. sect 7106
  - d. 61 Pa Section 91.156, 91.170
  - e. 68 Pa. C.S. section 2117, 2109
  - f. 15 Pa C.S. sect 5957 (b)

This is public information that I am requesting from you as a Public Servant in the post of Treasurer. The Pennsylvania Right To Know Law enactment act of Feb. 14 2008 P.L. 6, no. 3. and or the Federal law for this request is under the Freedom of Information Act (5 U.S.C. 552) and the Department's FOIA Guide and rules at 28 CFR 16.1 et seq.,

Your failure to respond to any question above does not invalidate any of the other points. 

Dear Mr. Wright:

Thank you for writing to Luzerne County with your request for information pursuant to the Pennsylvania Right- To-Know law ("RTKL").

Recently, the Luzerne County Office of Law received a request for documents from you described in the attached Right To Know request. Your request is granted in part and denied in part because Luzerne County does not maintain these documents. §705 of the RTKL states that "when responding to a request for access, an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner in which the agency does not currently compile, maintain, format or organize the record".

Please note Ms. Beers is not an elected official and therefore does not require an Oath of Office. We do not have any foreign agent registration information. Finally, attached please find a copy of the bond for Ms. Beers. This is on file in the Luzerne County Prothonotary's office. This does not require a right to know, you may appear at the Prothonotary's office and request it. Further, in the future we ask that you use the form that is on our website when submitting a right to know. You will find it much easier than sending in the formal letter you have been sending in, no notary is required for your convenience. We would also ask you to send your requests to one of the Open Records Officers listed on the County website, not to individual departments.

You have a right to appeal this denial of information in writing to Executive Director, Office of Open Records, Commonwealth Keystone Building, 400 North Street, 4<sup>th</sup> Floor, Harrisburg, PA 17120.

If you choose to file an appeal, you must do so within 15 business days of the mailing date of the agency's response. Section 1101. If you have further questions, please contact Laura C. Dennis. Please be advised that this correspondence will serve to close this record with our office as permitted by law.
