

**RESOLUTION R-2022-66  
LUZERNE COUNTY COUNCIL**

*A Resolution of Luzerne County Council Amending Resolution 2022-18 Which Approved  
a Budget Transfer to Allot Funds to the County Manager Search Committee*

WHEREAS, Luzerne County Manager C. David Pedri submitted his resignation effective July 6, 2021; and

WHEREAS, the Luzerne County Home Rule Charter at section 4.02 requires County Council to appoint a Search Committee to search for, screen, interview and recommend the most qualified candidates to County Council for final selection and appointment of a full-time County Manager; and

WHEREAS, on February 8, 2022, County Council voted to allot funds to the appointed County Manager Search Committee for their utilization in the process of recruitment, screening and identification of qualified candidates for full-time County Manager; and

WHEREAS, pursuant to Section 5.07 of the Home Rule Charter of Luzerne County, County Council adopted the 2021 Fiscal Year Budget which accounted for anticipated revenue and expenses; and

WHEREAS, Section 5.10.E. of the Home Rule Charter states at any time during the fiscal year, County Council may, by resolution adopted by an affirmative vote of at least a majority of its current members, make transfers of part or all of any unencumbered balance from any division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function to any other division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function; and

WHEREAS, County Council for Luzerne desires to amend Resolution 2022-18 for the transfer of funds in the budget to correct an error in a line item number for the transfer funds from the Reserve Fund to the Recruitment Expense line item to account for the allotment of funds to the County Manager Search Committee.

NOW, THEREFORE, be it RESOLVED by the Luzerne County Council:

**SECTION ONE. Incorporation of Preamble.**

The provisions set forth in the preamble to this Resolution are incorporated herein by reference in their entirety.

**SECTION TWO. Transfer of Funds Between Budget Line Items.**

County Council hereby authorizes the transfer of funds between line items in the 2022 fiscal year budget in order to transfer funds from the Reserve Fund to the Recruitment Expense line item in order to allot funds to the County Manager Search Committee:

Subtract funds from the Reserve Fund at line item 100.99.4940.585.10 in the amount of \$10,000.00.

Add funds to the Recruitment Expense line item of 100.10.4111.560.84 in the amount of \$10,000.00.

**SECTION THREE. Remainder of Budget.**

All other line items in the 2022 Fiscal Year Luzerne County Budget shall remain unchanged.

**SECTION FOUR. Effective Date.**

This Resolution shall become effective immediately.
