WHEREAS, Section 5.10 E. requires County Council to make budget transfers from any division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function to any other division, elective office, the Judiciary, Office of Court Administration, or other administrative unit or budgetary function by Resolution adopted by an affirmative vote of at least a majority of its current members;

NOW THEREFORE, BE IT RESOLVED, the Luzerne County Council shall make the following budget transfer for the FY 2016 County General Fund Budget as detailed in the attached Budget Transfer Request.

This Resolution shall become effective six (6) days after adoption.

ADOPTED this 23<sup>rd</sup> day of August, 2016 by the Luzerne County Council.




