

**WAIVER OF ARRAIGNMENT**

1. I, \_\_\_\_\_, acknowledge that I have received a "Notice of Dispositional Hearing" or "DUI Call of the List", Copies of the information(s) stating the charges filed against me by the District Attorney will be made available at the time of this hearing.
2. I am aware that I have a right to have the charges against me, as contained in the information(s), read to me, word for word, in open court, after which I will be asked to state whether I plead "Guilty" or "Not Guilty".
3. I am further aware that by my own choice, I may bypass the Arraignment procedure by waiving it, that is giving up my right to be formally arraigned. In the event I choose to do so, a plea of "Not Guilty" will automatically be entered on my behalf.
4. I have been advised by my attorney in accordance with Rules of Court as to my rights as follows:

- a. I have a right to be represented by a lawyer of my own choice, or I may represent myself. I am further aware that if I believe I cannot afford a lawyer to represent me, I may immediately make application to the Office of the Public Defender's Office, Luzerne County, 20 N. Pennsylvania Avenue, Wilkes-Barre, PA 18711.
- b. I have a right to file a "Request of Bill of Particulars" within seven (7) days following the scheduled date of my Arraignment/Dispositional Hearing and ordinarily not later than that.
- c. I have a right to file a "Motion for Pre-Trial Discovery and Inspection" within fourteen (14) days following the scheduled date of my Arraignment/Dispositional Hearing and ordinarily not later than that.
- d. I have a right to file various other motions, and any such other motions I may wish to file must ordinarily be filed within thirty (30) days following the scheduled date of my Arraignment/Dispositional Hearing and are to be filed in one (1) document titled "Omnibus Pre-Trial Motion".
- e. I understand that the **scheduled date** for my :
